## 5. Basis of Student Assessment (Weighting)

## 1. First Examination- 20%

The first exam will be held in class on **February 2nd**. It will consist of Fill-In-the-Blanks, Short Answers, and Essay Questions. A review and exam preparation session will be held in class on January 28th. This examination will serve as a preview of the other examinations in this course and of the level of performance expected in the course. The format of the three examinations will

be similar and this preliminary examination should be used as a guide in evaluating the effort and skills required for successful completion of this course.

## 2. Second Examination- 20%

A second examination will be given in class on **March 11th**. It will consist of three sections: Fill-In-the-Blanks, Short Answers, and Essay Questions. The exam will be based on material covered to date and will include material from lectures and required readings. A review and exam preparation session will be held in class on March 9th.

## 3. Case Summary Assignment - 30%

Students must write a critical summary of five cases plus a comparative conclusion. Total length of the assignment should fall in the range of 750 to 1000 words. A separate handout will be provided as a guide for this assignment. Summaries are **due March 23rd.** No summaries will be accepted after the last class on April 8th.

### 4. Final Examination- 30%

A final examination will be given during Final Examination Week, **April 12-20th.** The exam will cover material presented in the course as a whole, though there will be extra emphasis on material presented since the second examination. A review and exam preparation session will be held in class on April 8th.

#### Standard Grading System (GPA)

#### **Temporary Grades**

Temporary grades are assigned for specific circumstances and will convert to a final grade according to the grading scheme being used in the course. Temporary Grade	Description
I	<i>Incomplete</i> : A temporary grade assigned when the requirements of a course have not yet been completed due to hardship or extenuating circumstances, such as illness or death in the family.
IP	<i>In progress</i> : A temporary grade assigned for courses that, due to design may require a further enrollment in the same course. No more than two IP grades will be assigned for the same course. ( <i>For these courses a final grade will be assigned to either the 3</i> <sup>rd</sup> course attempt or at the point of course completion.)
cw	<i>Compulsory Withdrawal:</i> A temporary grade assigned by a Dean when an instructor, after documenting the prescriptive strategies applied and consulting with peers, deems that a student is unsafe to self or others and must be removed from the lab, practicum, worksite, or field placement.
