Course Description and Intended Learning Outcomes

Basic learning principles are applied to everyday problems. How to deal effectively with such diverse situations as bedwetting, tantrums, non-compliance, stealing and lying in children; adult problems such as obesity, smoking, incompatibility in marriage, headaches and phobias are considered. Learning is achieved through group discussion and creative role-play situations.

Upon completion of this course the student will be able to:

- 1. Define and diagram procedures used in behaviour analysis.
- 2. Explain the advantages and/or disadvantages of choosing a specific behavioural procedure when given a case example of behaviour.
- 3. Describe ethical considerations when choosing to use any behaviour modification procedure.
- 4. Explain single-subject research design and how the various methodologies meet or fail to meet the rules of scientific inquiry
- 5. Analyze and describe the behavioural procedures used in a variety of research and applied examples.
- 6. Write an APA style research paper reviewing current research in behaviour analysis.

Evaluation Methods:

1. Tests: There will be four in total, covering approximately 5-7 chapters each. They will

not be cumulative. These tests will count for 12.5% each for a total of 50% from tests. Format for these tests will be a variation of 1/3 marks from multiple choice, true/false, matching, etc., 1/3 marks from short answers (1-3 sentences long) and

1/3 marks from paragraph answers (5-7 sentences long).

2. Seminar Assignments: There will be 6 of these in total asking you to apply behavioural concepts to a case study (presented and completed in class). They count for 5% each toward your final grade for a total of 30% from assignments.

3. **Research Paper:** I will give you a separate detailed hand-out concerning the project and paper during the second seminar class. It will be worth 20% of your grade.

Summary of Evaluation:

Tests: 4 X 12.5% each = 50% of total grade

Assignments: 6 assignments X 5% each = 30% of total grade

Paper: 20% of total grade
