## 2. Intended Learning Outcomes

This course is an introduction to techniques of writing nonfiction: expository writing which combines characteristics of literature, journalism and the personal narrative. The familiar fundamentals of effective persuasive writing - providing a clear context and warranted reasons and evidence in support of a claim - are necessary underpinnings for an exploratory and reflective writing style and you've had some experience of course, writing basic research papers. This course assumes students have a certain maturity in their prose and self-awareness as writers. Focus in this class is on development of the writer's literary voice and style to explore experience (family, culture, community, travel, health, and historical or personal history, for example) with emphasis on the creative use of setting, character, narrative action and arc, motif, symbol, and possible archetypal themes. The idea is to expand our sense for nonfiction from the standard essay to the range of other forms like (for example) memoirs and reviews. Text readings will be used as prompts, models, or jumping-off points for students to produce writing but the course is designed to be rather open and flexible in approach and topics you might pursue. The course will involve intensive reading and writing and offers practice in writing a variety of prose forms. Stress is placed on developing the student's ability to order and structure material into its most effective form. Individual assignments will be written weekly over the semester and range from 500 to 2,000 words (course total of 5,000-5,500 words).

## 5. Basis of Student Assessment (Weighting)

#### (a) Assignments

1. 25%: Personal Essay/Memoir - This essay should link an experience relevant to a larger observational point about life. Your primary source will be individual

experience (2-3 pages).

- 2. 25%: Criticism/Review This essay will be an extended review of a cultural event: live or recorded music, film, theatre performance, book, lecture, consumer good, food/restaurant, sporting event, etc. Your goal will be to describe and evaluate the item under review- no formal research is required but clearly any material used or consulted (for example a program for a play; a CD booklet) must be cited (2-3 pages).
- 3. 25%: Reflective Essay/Article This essay should be a reflection of sorts in the sense that it should demonstrate knowledge and command of the topic much like the more traditional argumentative essay you've written in the past. The idea here is that you think of a the essay as a feature article in a publication of some sort. This paper should include some formal research at least four sources and be formal in tone and focus (4-5 pages).
- 4. 25%: Journal Postings & Participation You are required to post to the discussion board five times over the term. The posting gives you a chance to both reflect on the required reading and your writing each week. While the journal postings need not be formal (I mark these for content, not expression as such), I presume some thoughtfulness here. Obvious hastiness or lack of effort will undermine your posting grade. I presume much effort here so please do devote time and effort to responding to the journal questions. Your journals give me a sense for how well you are keeping pace with the course material and also illustrate your understanding of the various readings. You are also expected to respond to at least 5 journal postings of 5 different students over the term. Your responses are not to be too cursory. Each response should be about 150 words in length. The D2L server logs when you access the course and what portions of the course you have read. I factor the logs into the calculation of your final participation mark.

Temporary Grade	Description
I	Incomplete: A temporary grade assigned when the requirements of a course have not yet been completed due to hardship or extenuating circumstances, such as illness or death in the family.

A word about grading standards: Merely fulfilling the terms of an assignment, and doing so in a competent, reasonable manner, is generally only enough for a grade in the B-range. A – range grades will only be awarded when work demonstrates notable creativity, insight and excellence.

All marked work is given only a letter grade to reflect the value of the submitted work. Marks are usually based on organization, quality of ideas and support, style and grammar, according to the following criteria:

A Range (80 - 100%) Superior level of achievement - worth consulting; exceptional insight into material or topic; detailed, significant discussion; effective organization for paper's purpose; fluent, error-free expression

B Range (70 - 79%) High level of achievement - worth keeping; competent treatment of material or topic but with less originality or perception than an A paper; full but not so detailed discussion as for A; organization contributing to sense but remaining workmanlike; expression free of errors

C+ (65 - 69%) More than satisfactory level of achievement; sound content, reasonably well organized; clear but somewhat mechanical organization; some errors that confuse flow and sense; may display content at the B or even A level but with a few serious mechanical errors.

C (60 - 64%) Sufficient level of achievement to proceed with next level – readable; acceptable but with commonplace content and/or inadequately supported; mechanical and/or confusing organization/expression

D (50 - 59%) Minimum level of achievement for which credit is granted – needs editing/reworking; limited content, incomplete organization; frequent errors in expression that confuse sense

F (Below 50%) Minimum level not achieved; inadequate or inaccurate content; incoherent organization; many errors in expression and lacks apparent effort

# Course Policy

### Attendance:

Though this is an online course, I presume "attendance" in the sense that the course requires participation by class members, so it is important that you contribute to the in order to class discussions. You are assumed to be reading and responding to course content. Note too that I assume you are privy to any course content changes or modifications to due dates for required work as these are posted online only.

## Assignments:

All assignments are mandatory and due according to the dates & times specified. Late work will not be accepted (except under extraordinary circumstances) and will receive a grade of 0 (zero) - no partial marks for late assignments are administered. If you do not hand in an assignment you FAIL the course. Do not e-mail assignments- post to the drop box. Please keep a copy of all work - including material you hand in - until final marks have been posted.
