- 4. Articulate an appreciation of criminal law in practice by participating in a mock trial that as closely as possible replicates a true criminal trial.

## 3. Required Materials

1. Criminal Law in Canada, Cases Questions and the Code Simon N. Verdun Jones, Harcourt Brace

This fine book is available at your friendly bookstore. On the spot financing is available. Earlier editions are usable, but check with me. The text is carefully chosen to offer the best **supplementary readings** to the lectures.

2. A copy of a *Criminal Code* is helpful, but not needed. It doesn't have to be current as the Code doesn't change all that much. The library (that's the big building with all the books) has a few *Criminal Codes* that you can access with your handy library card.

#### Crim 270 Annotated Casebook

This casebook is required. It is available in the bookstore for a minimal charge – cheaper than you could photocopy one. It will be available by the third class. I update and annotate the casebook each summer - so do not get one from last year.

# 5. Basis of Student Assessment (Weighting)

**Exams –** There will be two. They will be true/false, multiple choice, and short answer. The dates are as follows and can not be changed. If you miss an exam, you fail... nice and simple.

1<sup>st</sup> Exam - February 24<sup>th</sup> 30%

2<sup>nd</sup> Exam – During the final exam period 45%

Case Summary – 20%. This is due on MARCH 23. You must find a partner – that means one person – then the two of you must write a case summary on a case that relates to the material we are doing in this class. For example, it can be a case from any level of court in Canada but it must relate to actus reus, mens rea, or one of the various defences we talk about in class. This summary CAN NOT be longer than 2 pages. It is a summary. Anything over two pages will not be marked. You need to find a case that is long enough that you can do a decent summary on, yet not too long that makes the two page rule difficult to comply with. And you must do this with a partner. The point of this assignment is to discuss the case between the two of you and do the summary.

**Peer Assessment – 5%.** Even more fun! You get to rip apart your partner. Okay, not so much rip apart but give constructive feedback. You are required to write a brief constructive assessment of your partner while doing the case summary. Please note, this assessment can move your overall mark by a letter grade... so put the effort in. The good assessments will be two paragraphs in length. Get the hint?

Mock Trial - bonus marks attributed for participation

One of the highlights of the term (other than the scintillating lectures) is the mock trial. This takes place at the courthouse or at the Maritime Museum in the oldest courthouse in B.C. Our mock trial will as accurately as possible resemble a real murder trial. Students will be the judge, lawyers, witnesses, jurors, and the accused. More details on this to follow. The mock trial will be outside of class time given our limited class schedule this term. We will discuss a date in class.
