### Intended Learning Outcomes

Upon completion of this course students will be able to

1. Identify and distinguish literary characteristics specific to children and youth as young readers.
2. Identify a variety of genres of fiction for children and youth including easy readers, early chapter books, juvenile fiction, short stories for children, and youth novels.
3. Practice the writing process appropriate to fiction for children and youth.
4. Produce plots, settings, characters with appropriate language and effective use of figures of speech.
5. Practice appropriate research for giving fiction credibility.
6. Identify the various resources available for writers.
7. Prepare a story for submission for publication.

We will be writing in class, sometimes working on assignments that will be handed in for assessment. It is therefore essential to your grade that you attend and participate in all classes.

## Basis of Student Assessment (Weighting)

Reading Responses and homework- 20%

- 4 x directed responses to readings
- 1 x story proposal
- 1 x character study
- 1 x story board (chapter outline)
- 1 x cover letter

Writing –80%

- 1st chapter – submit for editing 5%
- 2nd chapter –submit for editing –5%
- Mid-term –submit revised first and second chapter 30%
- 3rd chapter –submit for editing 5%
- Final –revised 3rd chapter 30%

Late assignments may lose marks at the rate of 5% per day. If there are known circumstances that will hinder you from completing an assignment on time, please speak with me well beforehand.

Students who fail to complete any assignments listed below by the final class date will fail the course. It is up to you to make sure that all of your assignments are handed in.

Temporary Grade	Description
I	<i>Incomplete:</i> A temporary grade assigned when the requirements of a course have not yet been completed due to hardship or extenuating circumstances, such as illness or death in the family.
IP	<i>In progress:</i> A temporary grade assigned for courses that, due to design may require a further enrollment in the same course. No more than two IP grades will be assigned for the same course. <i>(For these courses a final grade will be assigned to either the 3<sup>rd</sup> course attempt or at the point of course completion.)</i>
