5. Basis of Student Assessment (Weighting)

<u>Lectures</u>: There will be two hours of lecture per week, usually on Mondays. The whiteboard will be heavily utilized and digital images will augment the traditional lecture style.

<u>Labs</u>: There are ten labs in the course. Each lab contains exercises to familiarize students with environmental issues, government and non-profit web sites, and the tools of geographic analysis. Most lab exercises, due to their use of Internet information, will be taken home for completion. Labs will have assigned due dates and late submissions will not be accepted once marked labs have been handed back.

<u>D2L</u>: I use D2L, a learning support software, extensively in this course. It is a fairly user-friendly site that allows you to access lecture notes, electronic lab exercises, hand in your assignments digitally, track your mark, participate in discussions and be alerted to upcoming due dates or changes in assignments. I strongly encourage you to use this support site in this course.

<u>Discussions</u>: There will be six opportunities during the term to discuss interesting and controversial ideas in both small groups and in the class as a whole. Your participation in these discussions will contribute to your final mark and, since not everyone enjoys conversation or debate, you can opt to submit a written summary of the issue addressed from your perspective and include your understanding of the insights brought forward by your group.

<u>Product Pitch</u>: You will be asked to present a product pitch on an eco-friendly innovation of your choice. Your pitch will be broadly judged on the appropriateness of your product selection, the catchiness and thoroughness of your pitch, and the quality of the research you put in to your promotion.

<u>Midterm Exam</u>: The midterm exam will be held on **Wednesday, October 8th** and will be a selection of short-answer, multiple-choice, and short essay-type questions. Attendance is mandatory and illness must be declared <u>before</u> the exam begins and confirmed with a doctor's note.

<u>Final Exam</u>: There will be a final exam during the College exam week. This exam will focus on the material from the second half of the course. Attendance is mandatory and alternate arrangements can only be made for documented illness.

Temporary Grade	Description
I	<i>Incomplete</i> : A temporary grade assigned when the requirements of a course have not yet been completed due to hardship or extenuating circumstances, such as illness or death in the family.
IP	<i>In progress</i> : A temporary grade assigned for courses that, due to design may require a further enrollment in the same course. No more than two IP grades will be assigned for the same course. (<i>For these courses a final grade will be assigned to either the 3</i> rd course attempt or at the point of course completion.)
cw	<i>Compulsory Withdrawal:</i> A temporary grade assigned by a Dean when an instructor, after documenting the prescriptive strategies applied and consulting with peers, deems that a student is unsafe to self or others and must be removed from the lab, practicum, worksite, or field placement.
