5. Basis of Student Assessment (Weighting)

- (a) Assignments: Five assignments worth 12% each. I've given you a brief description here. (each assignment is fully outlined under the heading "Assignments" in the content section.)
 - 1. Application of Bronfenbrenner Model to pivotal point in your childhood.
 - 2. Analysis of a case study from 3 different theoretical perspectives
 - 3. A pamphlet for expecting parents high-lighting effects of a teratogen, birth options in BC or parental support of a newborn
 - 4. Observation of a Toddler Narrative of Development
 - Discussion of Gender Stereotyping and an analysis of toys marketed to boys versus girls
- (b) Research Paper: 30% This paper asks the student to observe a child in infancy/toddlerhood, preschool or middle childhood and to conduct some activities aimed at informally assessing cognitive development, physical development or social/emotional development. The student will tie this in to a multi-systemic theory. A detailed summary of the paper will appear under "Research Paper" in the content section.
- (c) Participation: 10% Each week, for 10 weeks, you'll be asked to take part in our weekly discussion. A posted discussion point that is relevant to the conversation, and brings insight or demonstrated knowledge to this discussion will be given 1%. A rubric outlining expectations is available under "participation" in content.

Temporary Grade	Description
