2. Intended Learning Outcomes

Upon completion of this course the student will be able to:

- Describe and evaluate traditional ethical theories in relation to ethical practice in healthcare and nursing.
- 2. Identify the theoretical underpinnings and consequences of people's positions on ethical issues.
- 3. Develop skills in ethical reasoning and judgment.
- 4. Describe the relationship between the CNA Code of Ethics and ethical theories, including an understanding of the role of professional values in ethical decision making.
- 5. Describe how ethical decision making is enacted in professional practice.
- 6. Through discussion and writing, resolve ethical dilemmas that arise in nursing practice.

3. Required Materials

- (a) Texts: None but I will reference Ethics in Canadian Nursing Practice by Oberle and Bouchal on occasion.
- (b) Other: There will be online readings. This course will make use of D2L.

4. Course Content and Schedule

Week 1: Introduction. Syllabus; Framework; Samples; Vocabulary.

Week 2: Thinking and Learning. Toolkit approach, Models/Naming, Templates, System 1/System 2, Telic/Paratelic, Stress, Narratives, Externalities.

Week 3: Arguing and Communication. The nature of Support/Argumentation, using Case Studies, Facts/Values, Language, Professional Voice (use & care), Consistent, Bad & Empty.

Week 4: Moral Theories. Virtue Theory, Ethical Egoism, Contractualism, Deontological, Utilitarianism, Moral Relativism, Ethics of Care, Return of Virtue, Moral Psychology, Everyday Ethics.

Temporary Grades

Temporary grades are assigned for specific circumstances and will convert to a final grade according to the grading scheme being used in the course. Temporary Grade	Description
1	Incomplete: A temporary grade assigned when the requirements of a course have not yet been completed due to hardship or extenuating circumstances, such as illness or death in the family.
IP	In progress: A temporary grade assigned for courses that, due to design may require a further enrollment in the same course. No more than two IP grades will be assigned for the same course. (For these courses a final grade will be assigned to either the 3 rd course attempt or at the point of course completion.)
cw	Compulsory Withdrawal: A temporary grade assigned by a Dean when an instructor, after documenting the prescriptive strategies applied and consulting with peers, deems that a student is unsafe to self or others and must be removed from the lab, practicum, worksite, or field placement.
