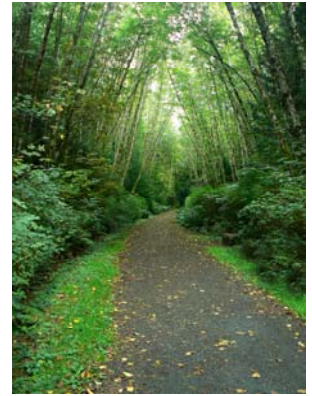

### **2. Intended Learning Outcomes**

Basic learning principles are applied to everyday problems. How to deal effectively with such diverse situations as bedwetting, tantrums, non-compliance, stealing and lying in children; adult problems such as obesity, smoking, incompatibility in marriage, headaches and phobias are considered. Learning is achieved through group discussion and creative role-play situations.

**Upon completion of this course the student will be able to:**

1. Define and diagram procedures used in behaviour analysis.
2. Explain the advantages and/or disadvantages of choosing a specific behavioural procedure when given a case example of behaviour.
3. Describe ethical considerations when choosing to use any behaviour modification procedure.
4. Explain single-subject research design and how the various methodologies meet or fail to meet the rules of scientific inquiry
5. Analyze and describe the behavioural procedures used in a variety of research and applied examples.
6. Write an APA style research paper reviewing current research in behaviour analysis.

#### 5. Basis of Student Assessment (Weighting)

**Online Discussion Points:** There will be 4 of these across term asking you to contribute an opinion/analysis/comment regarding a current social condition. You will be informed about these in class, at least one week in advance. Each of these counts for 3% of your final grade for a total of 12% from discussions.

**Seminar Assignments:** There will be 6 of these in total asking you to apply behavioural concepts to a

case study (observations in field, case files, etc.). **The top 5 scores count for 12% each toward your final grade for a total of 60% from assignments.**

**\*\*\*Please note: Assignments will only be available in seminar class and you will be asked to sign an attendance sheet. No make-ups will be provided. As only 5 of your scores will count toward the final grade, a missed class can simply be one of your missed scores.**

**Research Paper:** I will give you a separate detailed hand-out concerning the project and paper during the first seminar class. **It will be worth 28% of your grade.**
