2. Intended Learning Outcomes

Upon completion of this course the student will be able to:

- 1. Describe major contemporary issues in psychology and explain their historical antecedents.
- 2. Apply psychological theories and understanding of current psychological issues to personal experience.
- 3. Conduct impartial studies of psychological topics and arrive at logical inferences and conclusions from collected data.

3. Required Materials

4. Course Content and Schedule

This course acquaints the student with major contemporary issues in psychology and considers their historical antecedents. Topics in Life Span Development, Personality, Abnormal Behavior, Motivation, Emotion, Social Cognition, Social Influence, and Social Relations are considered.

Prerequisites: English 12 or assessment.

Course Organization:

Classes will be comprised of lectures and experiential work. Material from the text and selected readings related to current psychological issues and treatments will be examined. Experiential work includes discussions, activities, and student presentations. Attendance and participation are very important for learning.

Video presentations – Overcoming a social issue Due May 23rd

In teams of three or four students you will be asked to make a PowerPoint video on a social issue that relates to the content of Psyc 130. Seminar teams will be formed during the second week of classes. The video will explore the social challenge as well as a solution. Students will show their video in class and answer questions from their classmates on the topic. Students will submit the video and a written document (title page, the script, and at least 4 references/sources using APA guidelines). Presentations will be graded on quality, accuracy, course relevance. Peer grading may make up part of the grade for this assignment. More guidance on this course project will be provided during the class.

Stages:

- 1. Group formation and topic selection
- 2. Background research
- 3. Script
- 4. Storyboarding/PowerPoint
- 5. Audio and references section
- 6. Class presentation

Temporary Grade	Description
