Written Assignment Requirements

All assignments, including all drop boxed readings MUST meet the basic requirements for academic writing in Criminal Justice. Use the *Writing Reference Manual for the Criminal Justice Program*. All assignments MUST be in APA format (1" margins, double spaced, Times New Roman font, 12 font, indent first line of first paragraph, running head, correct cover page). All assignments submitted for evaluation in this course must be original and produced for the purposes of this course only. The submission of assignments completed for other courses may be construed as academic dishonesty.

PARTICIPATION

Before each class, complete the reading and preparation assignments. Assume someone else will be reading your responses (this helps with writing for clarity).

Drop box the graded assignments into the D2L before 1:00 pm on the class date.

Bring your assignments to class (both typed and printed out, or available on a laptop). Access through a phone is not an option. There is a sign in sheet (.2 of the 1 mark) for assignments brought to class. The quality of your responses is graded from thorough and detailed (1) to some detail (.7) to vague and general (.5). Incomplete work is graded at .3 maximum.

As a reminder APA is also graded.

B. Temporary Grades

Temporary grades are assigned for specific circumstances and will convert to a final grade according to the grading scheme being used in the course. Temporary Grade	Description
I	Incomplete: A temporary grade assigned when the requirements of a course have not yet been completed due to hardship or extenuating circumstances, such as illness or death in the family.
IP	In progress: A temporary grade assigned for courses that are designed to have an anticipated enrollment that extends beyond one term. No more than two IP grades will be assigned for the same course.
CW	Compulsory Withdrawal: A temporary grade assigned by a Dean when an instructor, after documenting the prescriptive strategies applied and consulting with peers, deems that a student is unsafe to self or others and must be removed from the lab, practicum, worksite, or field placement.
