## 5. Basis of Student Assessment (Weighting)

#### Assignments

- Important Note: Students are expected to complete their own project and other assignments. In small group projects, all students are expected to participate and contribute to their completion. Copying answers or using works from others are not permitted. Students found violating the Student Conduct Policy will be assigned an F for the assignment or the course.
- **On-line discussions (20%):** a total of 7 on-line discussion forums will be posted throughout the semester. Students will have one week to post their answers or comments before the discussion forums are closed. Discussions are base on in-class lectures, films, speakers' comments, and other out of class readings. A selected number of the discussion forums will be graded. The evaluation of the discussions will be based on the extent that you understand the issues concerned, provide a critical analysis, connect to course concepts, write in appropriate style and organize the materials effectively. Each submission should be no more than 150 words.

- Project (27%): The themes of this year focus on globalization: patterns and impacts. Students can either do it individually or form a small group of 2 to develop either a research project or a service learning activity. An outline of the project (5%) has to be submitted for approval (see schedule for due day). All research projects or service learning activities have to be submitted in the form of power-point (22%). The power-point project will be evaluated by its content (included adequate description and analysis), organization of materials, appropriate use of photos, graphs, maps, etc, and proper citation of sources and consistent design. Students conducting an extensive service learning project may be allowed to shift a maximum of 10% from another assignment. The request must be made in writing as part of the project's proposal. Consult the instructor for details
- <u>In-class Participation</u> (5%): Participation is an essential part of the course. Students are expected to participate in class activities and discussions.
- **Presentation** (8%): Each individual or group is required to present a 10-15 minute oral summary of their project as scheduled. The order of presentation will be assigned by the instructor according to the topics. The evaluation of the presentation is based on speaking style (clarity, pace and engage audience), content (description and analysis), organization and time management. Students are encouraged to seek advice from the instructor or counsellors early in the semester to develop a plan if they have any concerns about oral presentations.

#### Tests

<u>Test 1</u> (20%): The first test will be based on the reading, lecture and lab materials covered in the first half of the course. Review questions will be provided. See schedule of activities for the test date.


<u>Test 2 (20%)</u>: The second test will be based on the reading, lecture, and lab materials covered after the first test. Review questions will be provided. See schedule of activities for the test date.

<u>Important Note</u>: A doctor's certificate or equivalent is required to take a supplementary examination. Other supplementary examinations <u>approved</u> by the instructor may be subjected to a penalty of 10% per day.

Temporary Grade	Description	
I	<i>Incomplete</i> : A temporary grade assigned when the requirements of a course have not yet been completed due to hardship or extenuating circumstances, such as illness or death in the family.	
IP	<i>In progress</i> : A temporary grade assigned for courses that are designed to have an anticipated enrollment that extends beyond one term. No more than two IP grades will be assigned for the same course.	
CW	<i>Compulsory Withdrawal</i> : A temporary grade assigned by a Dean when an instructor, after documenting the prescriptive strategies applied and consulting with peers, deems that a student is unsafe to self or others and must be removed from the lab, practicum, worksite, or field placement.
