#### Labs

Students will complete five labs during the course. Each lab is worth 5% of the final grade. All students will complete the group labs. Students will choose two of the individual labs (lab 1, lab 3, lab 6, lab 7).

The purpose of the labs is to apply specific concepts covered in the course. Labs are due at the start of class on the dates indicated in the schedule. Labs should be approximately 400 words (include a word count) and should be typewritten. *A hard copy of the lab is required for marking purposes.* Late labs will only be accepted in <u>exceptional</u> circumstances and will require supporting documentation.

#### Quizzes

There will be four quizzes during the term. Quizzes will be written during the first 15 minutes of class on weeks 3, 5, 11, and 13. Quizzes will be comprised of ten questions (multiple choice, T/F, and/or matching questions). Quizzes are each worth 5%. *Students are encouraged to use the Launchpad resources to prepare for quizzes and exams.* 

#### Examinations

There are two exams in the course. They will be made up of short answer, fill-in-the-blank, multiple choice, matching questions, questions based on class activities, and your choice of a long answer question. Both exams are worth 25% of the final grade. The final exam is not cumulative. Final exam dates will be posted by the end of February.

#### **Participation**

Student participation is assessed based on: attendance and active participation in class activities; attentiveness in class; being mindful of others and demonstrating respect for the learning environment, effective communication skills, being prepared for class (course readings, D2L content, etc.)

#### **Bonus Question**

A bonus questions is available for extra, optional marks. The bonus question is worth 3% of the final grade and is due on April 4th.

Late penalty for assignments is 3% per day.

Temporary Grade	Description	
I	<i>Incomplete</i> : A temporary grade assigned when the requirements of a course have not yet been completed due to hardship or extenuating circumstances, such as illness or death in the family.	
IP	<i>In progress</i> : A temporary grade assigned for courses that are designed to have an anticipated enrollment that extends beyond one term. No more than two IP grades will be assigned for the same course.	
CW	<i>Compulsory Withdrawal</i> : A temporary grade assigned by a Dean when an instructor, after documenting the prescriptive strategies applied and consulting with peers, deems that a student is unsafe to self or others and must be removed from the lab, practicum, worksite, or field placement.
