2. Intended Learning Outcomes

Upon completion of this course the student will be able to:

- 1. Identify and evaluate the concept of juvenile delinquency/youth crime and the range of behaviours included under this concept.
- 2. Report in depth on the magnitude and impact of youth crime in Canada.
- 3. Identify and critically assess the theories purported to explain juvenile delinquency/youth crime.
- Evaluate in depth juvenile justice legislation (e.g. Youth Criminal Justice Act, Young Offenders Act) in terms of underlying philosophies and current interpretations (e.g. definitions & legal processes).
- 5. Identify and review current and critical issues relating to youth justice in Canada.
- 6. Identify future trends in social responses to youth crime and youth justice.

AGENCY PRESENTATION AND HANDOUT (10%):

Each student will be required to present on a youth serving organization or agency in a class poster session. The agencies presented will be those that supports young offenders and/or involved in the youth criminal justice process or youth at risk. You will be responsible for

researching your agency assigned in class and preparing a presentation describing their roles, responsibilities, types of services they provide, for whom and how they are funded and supported. You will be required to present a one-page handout to the class on the program/agency. Presentation session will be held April 4th, 2019. Additional information will be provided in class.

WRITTEN ASSIGNMENTS:

In this course, you are required to complete two thought papers. All papers must be submitted at the start of the lecture on the day that they are due.

THOUGHT PAPERS 2 (20% - 10% each)

You will be required to complete two thought papers for this course.

Your thought papers should be a short (1-page minimum, 4 pages maximum) independently written paper where you explain your opinion towards the assigned statement or question. These short papers are designed for you to write using only the materials learned directly from the lectures and assigned textbook and readings for this class. No additional research or references is required. In the thought papers, I am looking for evidence of critical thinking regarding an important course concept. While I will assign some points for grammar, writing style, and organization, the main focus of my feedback will be the degree to which you demonstrate comprehension of the important concepts discussed in this course and discuss them adequately and concisely in the allotted page range.

<u>**Thought Paper 1**</u> is due in week 4 - January 31, 2019. Assignment question will be handed out in class in week 2 and posted in Blackboard.

Thought Paper 2 is due at the start of class on week 9 - March 14, 2019. Assignment question and information will be handed out in class in week 4 ad posted in Blackboard.

YOUTH COURT REPORT (10%)

Students will be attending Youth Court in Victoria. You will be required to hand in a report that discusses your observations and description of Youth Criminal Justice Court process. A template and questions for the report will be provided in class.

Exams (50% - Midterm 20

There are two exams in this class that account for 50% of your final grade.

Exams are based on the information presented in lectures and in the text. Please keep in mind that I do not always lecture directly on the information presented in the text, but on related information not found in your text. As such, it is important to attend all lectures.

GROUP PRESENTATION (15%)

You are required to participate in a group 20 minute presentation. Presentations will be held in the last week of class and all group members will receive the same grade for the presentation.

You will be randomly assigned to a group. Each group will be given a case study of a young offender. In your presentation, each group must provide the following four things: 1) a summary of the case study; 2) an appropriate theoretical perspective with which to understand and explain the youth's behaviour; 3) an appropriate criminal justice system response to their criminality using the sentences available under the YCJA; and 4) discussion questions for the class.

Each group must submit a 1 to 2 page summary of their presentation the day of their presentation.

All members of the group will be evaluated in the following manner:

- 1) Presentation style
- 2) Presentation content
- 3) Ability to inspire discussion and respond to audience questions
- 4) 1 to 2 page written summary of your presentation

Participation 10%

Students will provide a self-assessment the last day of class outlining what they feel their grade should be out of 10 for participation in this course. Assessment will be based on attendance, participation in and out of class, readings, discussions and contributions in class and group work. Self-assessments will be used to assist in the grading and will be reviewed by the Instructor when assessing the mark for participation in this class.
