2. Intended Learning Outcomes

Upon completion of this course the student will be able to:

- 1. Describe the approaches and perspectives in economic geography and the location and distribution of economic activities.
- 2. Identify the principles, processes, and issues related to the location, diffusion and distribution patterns of primary, secondary and tertiary activities.
- 3. Explain the changing location and distribution patterns of economic activities at the international, regional and local levels.

3. Required Materials

There is no textbook for this course. All required readings will be provided by the instructor and posted to the course website.

4. Course Content and Schedule

• Lectures: Attendance is essential. I will post basic lecture outlines to the course website but these are no substitute for coming to class. The class has two two-hour blocks per week and will generally follow the format of having one lecture and one seminar session per week. Consult the course schedule for details.

- **Readings:** Readings are an essential part of the seminar sessions. They provide depth and context that are indispensable for your understanding of the course material and they will be tested. Specific reading assignments are detailed in the course schedule.
- Assignments: There are two major assignments that must be completed for this class. The assignment due dates are outlined in the course schedule. I reserve the right to impose a 10% per day penalty on late assignments. Anyone caught cheating or copying work will receive a mark of zero on the assignment.
 - Film Review: You will prepare a 3-4 page (double-spaced) review of one of the films we watch in class, connecting it to one or more course concepts. Details of the assignment will be discussed in class and I will give you a series of questions to think about when we watch the films that will be helpful in informing your review. The assignment is due March 20th.
 - Photo Essay: You will prepare a photo essay comprising 10-12 photos and corresponding paragraphs focused on an aspect of work in the service economy. Potential topics could include: gender and work, casualization of work, unionization, struggles over wages, precariousness, risk, aesthetic labour. These will be discussed in more detail in class. You will also deliver a presentation (~10min) summarizing your essay. Details of the assignment will be discussed in class. The assignment is due April 3rd.
- **Tests:** There will be two tests. The format for each will be a combination of multiple choice, short answer, and long answer questions. They will mainly emphasize lecture material but seminar materials will also be drawn upon. The second test will **NOT** be cumulative.
- Illness, etc.: If you miss a test due to illness or some other serious reason, I must ask you to
 provide a doctor's note or other documentation to support your story. Otherwise, a mark of zero
 for the missed test will be given. Tests are difficult to reschedule so please try not to miss them
 unless you absolutely cannot come to class that day. Students who miss a test <u>must</u> contact me
 <u>within 24 hours</u> with an explanation. In such cases, one makeup test time will be scheduled, and
 all students needing it will be expected to attend.
- Course schedule: Will be provided the first day of class.

| Temporary Grade | Description |
|--------------------|--|
| I | <i>Incomplete</i> : A temporary grade assigned when the requirements of a course have not yet been completed due to hardship or extenuating circumstances, such as illness or death in the family. |
| IP | <i>In progress</i> : A temporary grade assigned for courses that are designed to have an anticipated enrollment that extends beyond one term. No more than two IP grades will be assigned for the same course. |
| CW | <i>Compulsory Withdrawal</i> : A temporary grade assigned by a Dean when an instructor, after documenting the prescriptive strategies applied and consulting with peers, deems that a student is unsafe to self or others and must be removed from the lab, practicum, worksite, or field placement. |
