2. Intended Learning Outcomes

Upon completion of this course a student will be able to (and in some cases critically assess):

- 1. The nature of politics, government, and the state, with special reference to Canada.
- 2. The geographical, historical, social, and international context of the Canadian political system.
- 3. The fundamental elements of the constitution, including its evolution.
- 4. Federalism, including federal-provincial tensions.
- 5. The tensions between nationalism and regionalism, with special reference to Quebec and Western alienation.

5. Basis of Student Assessment (Weighting)

Marks will be determined based on the following work:

1. Reading Quizzes – 10%

With each new chapter or reading students will be asked to take an online multiple choice quiz that accompanies the textbook. The quizzes will cover the reading for that week (a chapter) and must be completed **prior** to the start of that week's class. The online submission window will close one hour prior to the start of that week's first class – **10:30 AM** on Mondays. There will be 10 reading quizzes throughout the semester.

3. Short Essays: 45% (15% per assignment)

Students will write three short essays (SE) of approximately 250 words each. A choice of four questions will be posted at the start of each section. Students will choose from one of the four questions. Students will be permitted to resubmit SE 1 or 2 by 11:59 PM on November 16. SE 3 permits students submit their work either individually or as part of a group of two. Papers should be just as well-crafted as a standard essay. Late assignments will be penalized 10% per day. 4. Website Project – 25% (10% Individual Short Essay, 5% Group Work Plan, 10% Website Presentation) Three-part project asks students to select key idea from course (list provided) and as a group create a website that highlights key ideas from that theme. Individually students will respond with a short essay to a specific question that relates to their topic area. The short essay will run approximately 250 words. It is due November 9th at 11:59 PM. Groups will submit a work plan that explains how they will divide the project among their colleagues. The work plan will explain content and page layout. It will serve as a blue-print for the website. It is due November 23 at 11:59 PM. Along with two mandatory prep days, groups will showcase their completed websites on the last day of class December 4. For more details, see the Website Project on the D2L content page.

5. **Engagement Grade** - 5%

All students will be asked to make a meaningful contribution to class activities and demonstrate engagement with topic. There are numerous ways for students to express their engagement. See the D2L site for a full account of participation grading.

6. Take Home Final – 15%

A final exam will consist of a take home essays due at **11:59 PM** on **Thursday December 12**. Students (no groups for this project) will have 84 **hours** to compose an essay of approximately 500 words in length. Students will answer one short essay question (from a choice of four) which draws from themes covered since the beginning of the semester. The essay will be submitted through the course's D2L Assignment drop box. For more information, see the D2L content page.

B. Temporary Grades

Temporary grades are assigned for specific circumstances and will convert to a final grade according to the grading scheme being used in the course. Temporary Grade	Description
I	Incomplete: A temporary grade assigned when the requirements of a course have not yet been completed due to hardship or extenuating circumstances, such as illness or death in the family.
IP	In progress: A temporary grade assigned for courses that are designed to have an anticipated enrollment that extends beyond one term. No more than two IP grades will be assigned for the same course.
CW	Compulsory Withdrawal: A temporary grade assigned by a Dean when an instructor, after documenting the prescriptive strategies applied and consulting with peers, deems that a student is unsafe to self or others and must be removed from the lab, practicum, worksite, or field placement.
