# 5. Basis of Student Assessment (Weighting)

Each assignment must be completed. If you do not complete an assignment you do not pass the course. We have a number of laboratory mice that missed one assignment, and we had to execute them.

**Exams** – There will be two. They will be true/false, multiple choice, and short answer. If you miss an exam, you fail... nice and simple.

## Mid Term Exam – February 14th 25%

In class. Pretty easy stuff. Just be caught up on readings and cases. It will be in the second half of the class that day.

# Final Exam – During the final exam period 40%

The college sets this and I have no control over the date. Don't be away! This will be a take-home open book exam that will be submitted via the Dropbox on D2L or e-mailed to the instructor

# Case Battle 2016 - 35%

One of the test mice suggested this during a debrief. I think it's a good idea. But she was drunk. Anyway, here's how it works....

The class is divided into teams of three. If we have an extra student we'll kick them out of class. Each team is assigned an opposing team. The first team must find a case that relates to issues we study in this class (see the list below for examples). The case must be from a trial court in Canada – that means not a court of appeal. The first team does a one-page synopsis of the case and delivers the case, plus the synopsis, to their opposing team and to me. The opposing team must then write an appeal decision of the case that disagrees with the trial decision. This part of the assignment is three pages in length. A copy is handed in to me when delivered to the Crown. Then, the Crown team does a one-page rebuttal of the appeal. And then the battle begins. During the final weeks of the class, the schedule will be handed out, each set of two teams with go head to head in front of the class arguing their case. The class will vote on the team with the best argument. The ground rules, order of argument, and the date of your group's battle will be handed out.

List of possible case issues: actus reus, causation, mens rea, transferred intent, indirect intent, automatism, self defence, mistake of fact, necessity, intoxication, insanity, duress...

Picking the case is very important. This MUST be approved by me before it is put to the other team. A bad case will make everyone's job very hard. Do not leave your case choice too long. You need to start this right away.

The first group is marked for the case they pick and the synopsis, the rebuttal, and the battle round. The second group is marked for the 3-page appeal and the battle round. Students are marked as a group for all written parts and individually for the battle round. The winning team in the battle round is given a bonus of up to 5% of the case battle mark.

Due dates for each part of this assignment will be handed out with the team lists early in the term.

The case battle has been changed to a three-page written group assignment. Using the above, provide a three page argument for your case and submit it to the D2L Dropbox or e-mail it to your instructor. Due on the last day of classes.

#### Mock Trial Cancelled

One of the highlights of the term (other than the scintillating lectures) is the mock trial. This takes place in the courthouse on Burdett. So yeah, a trial in a real courtroom. Our mock trial will as accurately as possible resemble a real murder trial (Liability Note: no student dies). Students will be the judge, lawyers, witnesses, jurors, and the accused. The class is divided into two teams: Crown and defence. This becomes a great class project and ends up with some wonderful moments of students fighting and catcalling. Warms my heart. More details on this to follow. We will discuss a date in class but it is usually near the very end of term.

Temporary Grade	Description
