METHODS OF EVALUATING YOUR LEARNING

Participation

Regular checking of the course webpage and active participation is required. It is expected that you will be constructive and respectful in all your communications and ask lots of questions regarding the material to ensure your understanding.

You are expected to complete the assigned readings before doing the coursework for each week. The lectures will address important points made in the assigned readings and address any areas that may need clarification. Keeping up with readings often becomes increasingly difficult as the semester moves along and as the completion of assignments takes a great deal of your time. I would strongly recommend that you use some type of planner where you can keep track of each weeks reading, assignment due dates and other expectations being placed on you.

It will be important to keep aware of current events throughout the semester and their impacts on the criminal justice system. Please utilize news media outlets daily to stay current of these developments.

Please let me know if you are sick or not feeling well on a particular week. I want to ensure everyone keeps pace but we are learning in this way due to the threat of an illness. Accommodations can be arranged in the event of illness so long as you are pro-active in communicating this to me as early as possible. Extensions on assignments can be arranged so long as they are arranged at least 72 hours (3 days) prior to the time they are due.

Criminal Justice Organization Analysis (25%)

Due Date: December 3rd, 2020

The purpose of this assignment is to use the appreciative inquiry style of learning to explore and report on what you have learned. The assignment will involve examining the role, responsibilities and key players within your assigned agency. You can examine harm reduction, crime reduction, victimization and overall community safety. This can be done creatively by using a recent crime or political happening relative to your agency.

Prepare a two (2) page report on your agency to be submitted in the D2L Dropbox. Proper APA style should be used so ensure you are using your *Criminal Justice Writing Reference Manual* for this assignment. This is due at the start of class time on December 3rd.

You will want to address the following questions in your write-up. At a minimum your analysis should be able to answer the following questions about your organization:

1. What is the formal name of the organization and, if they are part of government, where do they fit in? (eg. What branch or ministry do they belong to or are answerable to?)
2. What are the functions or responsibilities of this organization? How does it relate to other parts of the justice system?
3. How large is the organization, is it local, provincial or national?
4. What are some (is a) pertinent issue that the organization is dealing with either at present or in their past? Describe how decisions made on this issue could affect other components of the justice system.

A Discussion Post will be set up to use throughout the semester to discuss your progress, questions, concerns and successes. Please use effectively as this will be the forum to gain assignment clarity for everybody. Fall 2020

MP/MLA Assignment (35%)

Due Date: November 17th (Beginning of class)

Individually, research your local Member of Parliament (MP) and Member of the Legislative Assembly (MLA) and their positions on justice related issues. Be sure to research their backgrounds and answer the following questions;

1. What is their role in Parliament? Do they have a Cabinet posting or are they a backbencher? Are they with the governing party or are they in opposition?
2. What is their position on a **justice** matter faced in their constituency? Describe the issue and their position.
3. What is their perspective on any of the following issues; Police/RCMP, victims, offenders, the judiciary, Crown Counsel, corrections, or aftercare/social service agencies.

You must choose the MP & MLA from the jurisdiction where you are currently residing on October 1st, 2020. Please place your current address (including Postal Code) in the introduction of your paper. Exceptions must be cleared with your instructor.

Prepare a 2-page report on each representative (4 pages of content) that will be submitted in the D2L Dropbox on November 17th at the beginning of class. Please use APA style and use the *Criminal Justice Writing Reference Manual*.

This will be a take-home style quiz that will test your comprehensive knowledge of the material presented in this course.

Temporary Grade	Description
