2. Intended Learning Outcomes

Upon completion of this course the student will be able to:

1. Outline the legislative basis, structure and functions of the various components of the Canadian criminal justice system.
2. Identify how each component of the criminal justice system interrelates with other components and with the larger society within which it operates.
3. Track the process of an accused person through the critical decision-making points of the Canadian criminal justice system.
4. Identify and critically discuss contemporary issues affecting the structure and operations of the Canadian criminal justice (e.g. youth justice, female offenders and Aboriginal justice).

There will be a mid- term exam 25%, and a final exam 30%. The exams will consist of some combination of true/false statements, fill-in the blank, multiple choice, short answer questions, and short essay responses. The format of each exam (e.g., number of questions will be discussed in class). Check the designated review classes listed below in the lecture schedule. More specific guidance will be provided during the designated class review.

2. Directed Paraphrasing Summaries 15%

Directed Paraphrasing is an informal assessment technique/strategy that aims to assess students' understanding of ideas and concepts that are discussed in class. Throughout the term, on random basis, students will be asked, prior to the end of class, or at the beginning of the following class, to write a directed paraphrasing summary about the discussed content in the class lecture. Students will write SEVEN directed paraphrasing summaries; each one worth 5 points and weighs 2% of your total mark.

3. Synthesis Project 30%

The purpose of this assignment is for you to demonstrate the knowledge you are acquiring about how the CJS operates by guiding "an offender" through the criminal justice process from the time of their first contact with the police to their release from the correctional facility. You are required to document and describe in details the various applicable procedures, options, and decisions made along the way. This would include decisions about arrest, release, formal charge, court appearances, plea trial, sentencing, incarceration, and post-incarceration release.

The synthesis project in its final form is written as a report. It has a table of contents, headings, an Introduction, and a Summary or Conclusion.

I have broken the project down into 4 areas (criminal event, police, courts, corrections) to help guide you as you develop your content and convey your understanding of the various processes, roles, and actual decision making by the various professionals involved with your offender.

The final form will have flow within each section, between paragraphs, and between sections. Keep in mind that you are explaining how the CJS works to someone who "does not know" how it works. Start with the Crime itself.

The Criminal Event must:

1. Describe the criminal event (who, what, when, where, why), victim, witnesses
2. Develop background information on the suspect/accused (offender profile).

The Accused

The accused person of your choice, either male or female must be:

1. Adult at the time of crime occurrence
2. Provide personal information about the accused like prior convictions, childhood history, addiction struggles, and mental illness.
3. Be accused/charged of committing an indictable offence(s).
4. Pleads "Not Guilty", then go to trial.
5. Be found guilty at sentencing
6. Sentenced for at least years incarceration (BEFORE any type of early release).
7. Discuss the impact of incarceration on the accused.
8. Inmate will appear before the Parole Board of Canada and will be granted conditional release.
9. Discuss the re-integration of the offender in the community (You may discuss the available means of support for the offender).
- 10. Offence is NOT first or second degree murder**

Further details and instructions about this assignment will be discussed in class.

Plagiarism is considered a serious academic offense. If plagiarism is documented by your instructor, the penalty will be an automatic "0" for that assignment. A general rule to follow is that 5 or more consecutive words taken from a document or other source should either be placed in quotations and referenced appropriately,

or, paraphrased and credited using a parenthetical citation.

7. Mark/Grade Challenges and Appeals

A student who is seeking to question a mark and/or informally resolve a grade appeal with the course instructor must clearly articulate in writing the specific element of the test or assignment being questioned and provide written reasons/arguments supporting why the mark/grade should be changed. Temporary Grade	Description

CW	<i>Compulsory Withdrawal:</i> A temporary grade assigned by a Dean when an instructor, after documenting the prescriptive strategies applied and consulting with peers, deems that a student is unsafe to self or others and must be removed from the lab, practicum, worksite, or field placement.
