## **Instructional Expectations & Requirements**

## 1. Late Penalty

All late written work will be penalized by 20% per day unless an extension is legitimately warranted AND approved by the course instructor in advance of the assignment due date.

#### 2. Written Assignment Requirements

All assignments must be submitted to the D2L assignment drop box by the time and date provided. If the submission of work is problematic, see the course instructor in advance of the due date. Written assignments must be type-written, double spaced, and meet the basic requirements as set out in the Criminal Justice Writing Reference Manual.

#### 3. Plagiarism, Cheating and Academic Dishonesty

If the course instructor can document plagiarism, cheating and/or academic dishonesty, the penalty will be an automatic "zero" on the assignment in question. Further disciplinary action may be taken as per Camosun College policy.

#### 4. Mark/Grade Challenges and Appeals

## 5. Basis of Student Assessment (Weighting)

#### Research Paper 25%

Each student is required to write a 6-8 page research paper on a correctional topic from an instructor approved list. Guidelines for this assignment will be distributed separately. Due: Tuesday Nov. 10th Hard Place To Do Time Assignment 10%

Students will write a 2-3 page reflection on this book or another book approved by the instructor. Due: Tuesday Oct. 6th

#### Exams 55%

Students will write a mid-term exam and final exam. These will be completed on D2L. The exams will be based on the material covered to date including lectures, discussions, videos, and readings. Exams will be a combination of multiple choice, true/false, and short answer questions. The exams are timed so they open at a specific time and you will have 80 minutes to complete and submit it. The final exam will not be cumulative other than broad concepts that carry over from the first half of the course. The mid-term exam will be worth 25% of your final grade and the final exam will be worth 30% of your final grade. The mid-term exam will be on Tuesday Oct. 20th during class time.

#### Participation in class activities 10%

Students will be given two assignments which will be done in groups or pairs. The instructor will assign the groups/pairs and you will complete the assignment with this person(s). You will need to communicate with your group member(s) using your phone/computer (not in person). These assignments will be completed and handed in to the assignment drop box on D2L. These assignments are worth 5% each.

Temporary Grade	Description
I	Incomplete: A temporary grade assigned when the requirements of a course have not yet been completed due to hardship or extenuating circumstances, such as illness or death in the family.
IP	<i>In progress</i> : A temporary grade assigned for courses that are designed to have an anticipated enrollment that extends beyond one term. No more than two IP grades will be assigned for the same course.
CW	Compulsory Withdrawal: A temporary grade assigned by a Dean when an instructor, after documenting the prescriptive strategies applied and consulting with peers, deems that a student is unsafe to self or others and must be removed from the lab, practicum, worksite, or field placement.
