Mid Term Exam - October 19th 25%

Final Exam – Last Class December 7th 40%

Like the mid-term, you will be emailed the exam and it will be due back after.

Case Battle - 35%

Here's how it works....

The class is divided into teams of 6-3 Crown and 3 defence per team. The defence team finds a criminal case on point with the issues in this class. Defence provides the case, plus a synopsis of the case, to the Crown and to me. In the synopsis the defence provides their grounds for arguing in favor of the defence in the case. Crown then writes a "reply" to the case and the defence grounds. This is delivered to the defence and me. And then the battle begins. Pre-Covid, it was an in-class battle. Now it's written and distributed to the class. The class will vote on the winner of each team. The ground rules, order of argument, and the date of your group's battle will be handed out. Please note: this all happens in November. It is meant to be a fast, focused, assignment.

Mock Trial

One of the highlights of the term is the mock trial. During Covid, this is not happening. Maybe after you graduate, if I'm still around, pop on by and take part in this.

B. Temporary Grades

Temporary Grade	Description
I	Incomplete: A temporary grade assigned when the requirements of a course have not yet been completed due to hardship or extenuating circumstances, such as illness or death in the family.
IP	<i>In progress</i> : A temporary grade assigned for courses that are designed to have an anticipated enrollment that extends beyond one term. No more than two IP grades will be assigned for the same course.
CW	Compulsory Withdrawal: A temporary grade assigned by a Dean when an instructor, after documenting the prescriptive strategies applied and consulting with peers, deems that a student is unsafe to self or others and must be removed from the lab, practicum, worksite, or field placement.
