#### 5. Basis of Student Assessment (Weighting)

##### Assignments

**Important Note:** Students are expected to complete their own labs, projects and other assignments. In small group projects or labs, all students are expected to participate and contribute to their completion. Copying answers or using works from others are not permitted. Students found violating the Arts and Science Academic Honesty Guidelines (<http://camosun.ca/learn/school/arts-science/images/Arts%20and%20Science%20Academic%20Honesty%20Guidelines.pdf>) or the Camosun College Student Conduct Policy (<http://camosun.ca/about/policies/education-academic/e-2-student-services-and-support/e-2.5.pdf>) will be assigned an F for the assignment or the course.

**Labs** (28%): a total of 4 labs will be assigned during the semester. Each lab will carry equal marks. All labs are to be submitted as scheduled (see schedule of activities). Students can work individually or in small group of 2 but **must form a new group each time or they will not receive marks**. Late labs are subject to a penalty of 2% per day and will not be accepted after one week from the due day.

**Project** (27%): The themes of this year focus on achieving development in Sub-Saharan Africa. Students are encouraged to form a small group of 2 or individually to develop either a research project or a service learning activity. An outline of the project (5%) has to be submitted for approval (see schedule for due day). All research projects or service learning activities have to be submitted in the form of power-point (22%). The power-point project will be evaluated by its content (included adequate description and analysis), organization of materials, appropriate use of photos, graphs, maps, etc, and proper citation of sources and consistent design. *Students conducting an extensive service learning project may be allowed to shift a maximum of 10% from another assignment. The request must be made in writing as part of the project's proposal. Consult the instructor for details*

**On-line discussions** (10%): A total of 10 on-line questions will be posted. Students are expected to answer the questions in their own words. Copying answers from other students or sources are not permitted. Students have one week to post their answers.

### Tests

**Test 1** (17.5%): The first test will be based on the reading and lecture materials covered in the first half of the course. Review questions will be provided. See schedule of activities for the test date.

**Test 2** (17.5%): The second test will be based on the reading and lecture materials covered after the first test. Review questions will be provided. See schedule of activities for the test date.

Students will be assigned to undertake the test on the scheduled date at various time slots. Inform the instructors at least one week prior to the test date if the scheduled time is in conflict with any of your other class schedules.

*Important Note: A doctor's certificate or equivalent may be required to take a supplementary examination. Other supplementary examinations approved by the instructor may be subjected to a penalty of 10% per day.*

Temporary Grade	Description
I	<i>Incomplete:</i> A temporary grade assigned when the requirements of a course have not yet been completed due to hardship or extenuating circumstances, such as illness or death in the family.
IP	<i>In progress:</i> A temporary grade assigned for courses that are designed to have an anticipated enrollment that extends beyond one term. No more than two IP grades will be assigned for the same course.
CW	<i>Compulsory Withdrawal:</i> A temporary grade assigned by a Dean when an instructor, after documenting the prescriptive strategies applied and consulting with peers, deems that a student is unsafe to self or others and must be removed from the lab, practicum, worksite, or field placement.
