5. Basis of Student Assessment (Weighting)

(a) Seminar Worksheets (10%, 10 at 1% each)

During each seminar, students will be asked to complete a short assignment based on the week's seminar reading. Students will be expected to analyze the case study using an Ethical Decision Making Framework (i.e. The CPA Way - Assess the situation, Analyze the major issue(s) – both professional issues and ethical issues, draw a conclusion and then communicate it effectively) and apply the various ethical theories studied. These will be submitted via D2L drop box by the due date and graded on a pass/fail basis. Reading the assigned lecture readings is essential preparation. The best 10 will form the grade for this portion of the course. No rewrites or deferrals. NOTE: You must have watched the lecture for that seminar worksheet to receive the seminar grade. Students who submit a seminar worksheet but who have not watched the lecture will receive a grade of zero.

(b) Case Study Analyses (30%, 4 at 7.5% each)

One assignment/interval on a case study drawn from the selection of cases in the chapters we are studying during the interval. Students will be expected to analyze the case study using The CPA Way (i.e. Assess the situation, Analyze the major issue(s) – both professional issues and ethical issues, draw a conclusion and then communicate it effectively) and apply the various ethical theories studied.

DST	The student has met and exceeded, above and beyond expectation, the goals, criteria, or competencies established for this course, practicum or field placement.
NC	The student has not met the goals, criteria or competencies established for this course, practicum or field placement.

B. Temporary Grades

Temporary grades are assigned for specific circumstances and will convert to a final grade according to the grading scheme being used in the course. Temporary Grade	Description
I	Incomplete: A temporary grade assigned when the requirements of a course have not yet been completed due to hardship or extenuating circumstances, such as illness or death in the family.
IP	In progress: A temporary grade assigned for courses that are designed to have an anticipated enrollment that extends beyond one term. No more than two IP grades will be assigned for the same course.
CW	Compulsory Withdrawal: A temporary grade assigned by a Dean when an instructor, after documenting the prescriptive strategies applied and consulting with peers, deems that a student is unsafe to self or others and must be removed from the lab, practicum, worksite, or field placement.

Policy on missed tests: Make-up tests will be permitted only in cases of illness or personal crisis. A make-up test will not be scheduled until proper medical documentation is provided.
