#### **COURSE GUIDELINES & EXPECTATIONS**

In order for you to gain first-hand experience in conducting psychological research, you will develop and write in stages throughout the semester a psychological research project involving a cross-sectional online study of BC paramedics that will investigate how their shift work patterns are related to their levels of fatigue, sleep quality, mental health, medical error, and safety. You will meet with me in weekly one-on-one meetings throughout the semester to discuss your progress in the research project and receive feedback from me on what revisions are needed. The following hard deadlines will need to be met in order to successfully complete the research project within the Fall 2021 semester:

- Ethics approval applications for this research project will need to be submitted to the Camosun Research Ethics Board (REB) and to the British Columbia Emergency Health Services (BCEHS) Research Evaluation Committee early enough to allow time to still fully carry out the planned research methods after receiving their ethics approval.
- While the Camosun REB states on their website (https://camosun.ca/innovates/applied-research/ethics-approval) that they meet six times per year and that the application deadlines appear in the Camosun Calendar of Events and in CamNews, the application deadlines for the Fall 2021 semester have not yet been released there. However, in recent years the Fall application deadlines have always been in mid-September and mid-November. Therefore, in order to have enough time to

- collect data, the ethics approval application should aimed to be submitted to them by mid-September.
- The BCEHS Research Evaluation Committee states on their website (http://www.bcehs.ca/our-research/researcher-resources) that they meet regularly but do not list the specific dates of their meetings. They also state that their reviews can take six weeks or longer.
- Although not required, it would be good scientific practice to also preregister the methods proposal before conducting the study - see <a href="https://www.psychologicalscience.org/observer/research-preregistration-101">https://www.psychologicalscience.org/observer/research-preregistration-101</a>

Since each stage builds on the work of previous stages, you must correctly complete each stage in order to receive marks on subsequent stages, with opportunities given throughout the semester for revisions of previous stages. , until the last week of classes has passed. You may revise and resubmit for marks your research assignments throughout the semester, without late penalties, until the last week of classes has passed. Research assignments not completed by this final deadline will receive a score of zero.
