#### **CALENDAR DESCRIPTION**

This course examines Canadian local government and politics with a focus on Vancouver Island and the Lower Mainland. Topics include electoral systems, local electoral politics, regional and municipal administration, service delivery and fiscal challenges, municipalities' relationship to Indigenous self-government, provincial and federal governments, and trends in urban development.

DESCRIPTION		WEIGHTING
Reading Quizzes (RQ):		
With each new chapter or reading students will be asked to take an online multiple-choice quiz in the course D2L website (in the Quiz section). The quizzes will cover the reading for that week (a chapter or a reading) and must be completed <b>prior</b> to the start of that week's class. Students have one attempt to successfully complete each RQ. The online submission window will close one hour prior to the start of that week's first class — at 5:00 PM on Mondays. The answers for each RQ are available once that RQ closes (5:00 PM on Mondays). There will be 10 reading quizzes throughout the semester; the lowest graded RQ will be dropped from each student's overall grade.		15%
Short Essays (SE): 15% per assignment		
Students will write three short essays (SE) of approximately 500 words each. A choice of questions will be posted at the beginning of each module. Students will answer one question from that module's selection. Short essays should be just as well-crafted as a standard essay. Late assignments will be penalized 10% per day. Group Discussion Reading Quiz (GDRQ):		
Online multiple-choice reading quizzes that cover readings for that week's group discussion. These quizzes are to be completed one hour <b>prior</b> to the start of Wednesday evening's online class. Students have one attempt to successfully complete the GDRQ. There will be 5 GDRQs; the lowest graded GDRQ will be dropped from each student's overall grade.		8%
Website Project (WP): 28% (15% Individual Short Essay, 5% Group Work Plan, 10% Website		
Showcase) The three-part project asks students to select a key idea from course (list provided) and as a group create a website that highlights key ideas from that theme. Individually students will respond with a short essay to a specific question that relates to their topic area. The short essay will run approximately 500 words. The WP Individual Short Essay is due November 13 at 11:59 PM. Groups will submit a work plan that explains how they will divide the project among their colleagues. The work plan will explain content and page layout. It will serve as a blue-print for the website. It is due November 23 at 11:59 PM. Along with two mandatory prep days, groups will showcase their completed websites on the last day of class December 4.
