Week 1 - Sept 09	Course intro Assign #1 (Part I) Marks and Traces: Exploring Mediums and Indications Using all the dry mediums and Chunghwa Ink (no paint) from your material list create a series of small area drawings that do not depict anything representational, but rather, explore different marks as pattern and form (refer to support material on D2L) experimenting with different mediums and make notes about what medium is used in each variation. Try the same technique of marks using different mediums to learn their benefits and limitations.	Course Materials required for Assignment 1
Week 2 - Sept 16	Assign #1 Part 1 DUE Assign #1 (Part II) Marks and Traces: Exploring Mediums and Indications On Newsprint and cartridge paper, using all the dry mediums (no Chunghwa Ink or Paint) from your material list, create a series of at least three rubbings (Frottage) of the same object using different mediums. You must make rubbings of at least 10 different objects of assorted sizes (small to large including cropping from large objects), this would be a total of at least 30 rubbings total (refer to support material on D2L). As is the case with part I and part II of this assignment the goal is not a representational drawing, but a series of related explorations that explore, exploit, and demonstrate considered control of various mediums and systems of mark making to create a picture (refer to support material on D2L). #### **COURSE GUIDELINES & EXPECTATIONS**

Assignments will account for most of your course grade. Student course work will be assessed on each assignments ability to demonstrate; informed experimentation, process comprehension, and exploration of the concepts introduced within 2-D studio practice. \*Students should plan to meet with the instructor if there is any uncertainty or concern regarding assignment guidelines, results, or course standing.

This studio-based course requires students to work on aspects of their assignments in class to develop shared learning, creative community, and experimentation. Students are responsible for safe, respectful, and clean use of the studio and materials. Studio etiquette requires students to clean up after themselves (or their group) each day before leaving the studio. Works left in common spaces 30 minutes prior to the next class start time, or 9am the next day will result in an immediate deduction of 3% per work (i.e., a painting left out to dry overnight not in designated storage spaces in Y117). Work may only be stored in designated storage areas (or with special permission of instructor and instructional technician). Students are reminded that storage is limited in capacity and security.

students may not use any tools, equipment, facility or engage in any VisArt processes while under the influence of any restricted drugs or alcohol.

students are required to report any accident to the instructor, technician, or other College employee. If the injury is of a serious nature than the College's industrial first aider must be notified.
