## 5. Basis of Student Assessment (Weighting)

(a) Assignments

SYNTHESIS PROJECT: (30%)

#### Purpose:

The purpose of this assignment is for you (or in pairs or groups of 3 or 4 maximum) to demonstrate the knowledge you are acquiring about how the CJS operates by guiding "an offender" through the criminal justice process from the time of their first contact with the police to their release from the correctional system. You are documenting and describing in detail the various applicable procedures, options, and decisions made along the way. This would include decisions about arrest, release, formal charge, court appearances, plea, trial, sentencing, incarceration, and post-incarceration release.

Temporary Grade	Description
I	Incomplete: A temporary grade assigned when the requirements of a course have not yet been completed due to hardship or extenuating circumstances, such as illness or death in the family.
IP	<i>In progress</i> : A temporary grade assigned for courses that are designed to have an anticipated enrollment that extends beyond one term. No more than two IP grades will be assigned for the same course.
CW	Compulsory Withdrawal: A temporary grade assigned by a Dean when an instructor, after documenting the prescriptive strategies applied and consulting with peers, deems that a student is unsafe to self or others and must be removed from the lab, practicum, worksite, or field placement.
