7. Recommended Materials to Assist Students to Succeed Throughout the Course

Class Community: This requires students to keep up with the course work and participate in the discussion forums. When everyone does the work (i.e., readings, quizzes, videos, thought) the quality of the discussion is elevated.

Regard the discussion posts as professional work; this means no slang, no swearing, best efforts for correct grammar and spelling. I trust we will all aim to write as if we are speaking to each other face to face, where dignity, courtesy and respect are constantly mandatory.

This is the 'ball park' for good participation. Over the course of the term, each student will post:

- post 10 discussion threads opened with a question
- post 35 – 40 replies
- and will read 100 comments

Homework Quizzes. There is a homework assignment set up on D2L for each chapter of the text. The quizzes can be completed anytime during the week. They always open at noon on Wednesday, and are due at noon the following Wednesday. (Except on February 10th when we skip the 17th because of reading break.) The quizzes are set up to allow two attempts. After the first attempt, the quiz tool will

show which answers were incorrect. This gives students a chance to correct their mistakes. Only the higher of the two scores will count towards the homework grade.

There will be no opportunity to complete quizzes once they have been closed. Each quiz has a completely strict deadline.

Tests Make-up tests will be permitted in cases of illness or crisis. Contact me as soon as you know that you either will miss a test or have missed a test. In the case of a personal crisis, students will be referred to the Camosun Counseling services. Rescheduling tests in advance is possible for any reason; for example because you have a major project due on the same day, three exams that week, an important Zoom-party to attend, etc. There is no problem in arranging makeup tests; but these arrangements need to be made as early as possible. They cannot be made after the fact, without support from Counseling services.

B. Temporary Grades

Temporary grades are assigned for specific circumstances and will convert to a final grade according to the grading scheme being used in the course. Temporary Grade	Description
I	<i>Incomplete:</i> A temporary grade assigned when the requirements of a course have not yet been completed due to hardship or extenuating circumstances, such as illness or death in the family.
IP	<i>In progress:</i> A temporary grade assigned for courses that are designed to have an anticipated enrollment that extends beyond one term. No more than two IP grades will be assigned for the same course.
CW	<i>Compulsory Withdrawal:</i> A temporary grade assigned by a Dean when an instructor, after documenting the prescriptive strategies applied and consulting with peers, deems that a student is unsafe to self or others and must be removed from the lab, practicum, worksite, or field placement.
