## CALENDAR DESCRIPTION

This course offers an introduction to music technologies used in contemporary artistic practice. Technologies introduced include software for score notation and Musical Instrument Digital Interface (MIDI), podcasts and videocasts, websites and social media, and basic audio/video recording and editing.

## COURSE LEARNING OUTCOMES / OBJECTIVES

Upon completion of this course a student will be able to:

1. Prepare and produce a fragment of musical score using score notation software for use in an educational music performance setting.
2. Perform a fragment of musical score using Musical Instrument Digital Interface (MIDI) to express accurately the sounding context of the music set.
3. Prepare and present a small segment of lecture-recital via podcast or videocast performance for personal archive use by the performer(s).
4. Record, edit, and render a simple video recording of a solo or small group musical performance for personal archive use by the performer(s).
5. Summarize elements of current social media opportunities and options in a technology context as these apply to promotion of the emerging professional musician.

## COURSE GUIDELINES & EXPECTATIONS

---

- A. The average amount of time spent working on materials for this course is 3 hours per week. The weekly schedule in the Course Schedule section, above, outlines the weekly/biweekly modules of content that are to be completed in order. For each week of the term, topics and assessment due dates are provided.
- B. The Evaluation of Learning section, above, outlines the basis of student assessment. The **participation** portion of your grade consists of seven (7) assessments in total: four (4) discussions, and three (3) self-assessment quizzes. The **exercise** portion of your grade consists of one (1) exercise. The **quiz** portion of your grade consists of two (2) quizzes. The **project** portion of your grade consists of three (3) projects. Assessments within each category (participation, exercise, quizzes, and projects) are weighted equally.
- C. In order to receive full credit for each of the graded assessments, you must submit them by their respective due dates and times. In the event you do not meet a submission deadline and you have not been given an extension (see Part D below), I will accept your late work with penalty. Points will be deducted for **each day** an assignment is late (1 point per day, up to a maximum of 30 deducted). Please do your best to submit your work as soon as you have completed it, even if the deadline has passed.
- D. Since this online course is asynchronous (no scheduled class meetings), missing class for holidays or illness is not a concern. You may, however, experience illness that prevents you from meeting a submission deadline. In order to receive an extension in this case, contact the instructor before the deadline and, if requested, forward documentation to the instructor from a doctor (or certified healthcare professional) as soon as possible, preferably before the deadline passes. This documentation is required to include a clear statement of **WHAT** you could not do and **WHEN** you could not do it (e.g., "Student was bedridden from March 5-7," or "Student will not be able to use right hand for two weeks, March 1-15"). It is not necessary to disclose the reason for your illness. Upon approval of your doctor's note, accommodations within reason will be made to help you complete missed work. Note: It is your responsibility to be aware of

assessment deadlines and to pace your weekly progress so that you are able to meet these deadlines. Please contact the instructor as soon as you anticipate that you might miss a submission deadline for any reason. Flexibility and generosity are ongoing as the pandemic continues.
