## COURSE GUIDELINES & EXPECTATIONS

---

### Research Paper 25%

Each student is required to write a 5-6 page research paper on a correctional topic from an instructor approved list. Guidelines for this assignment will be distributed separately. **Due: Friday November 12<sup>th</sup> by 3pm to the drop box on D2L**

### Book Assignment 10%

Students will write a 2-3 page reflection on a book or another book chosen at the start of the semester. **Due: Friday October 8<sup>th</sup> by 3pm to the drop box on D2L**

### Exams 55%

Students will write a mid-term exam and final exam. The exams will be based on the material covered to date including lectures, discussions, videos, and readings. Exams will be a combination of multiple choice, true/false, and short answer questions. Students will have the first 80 minutes of class to complete the mid-term exam. Similarly, the final exam will be 80 minutes. The final exam will not be cumulative other than broad concepts that carry over from the first half of the course. The mid-term exam will be worth 25% of your final grade and the final exam will be worth 30% of your final grade.

### Participation in class activities 10%

Students will be given two assignments which will be done in groups or pairs. The instructor will assign the groups/pairs and you will complete the assignment with this person(s). These assignments will be completed and handed in to either the assignment drop box on D2L or directly to the instructor. These assignments are worth 5% each.
