COURSE GUIDELINES & EXPECTATIONS

(a) Trigger Warning & Appropriate Behaviour

Due to the nature of this course, we will cover topics in lecture that could be distressing or triggering to some students. The course schedule shows the lectures where that material is mentioned, however, that material does and could appear in other lectures. Further, inappropriate behaviour will not be tolerated. (b) Missing Classes
