This course presents experimental methodologies used in psychology, including how data is collected, organized, and interpreted in psychological research. Topics: psychobiology, sensation, perception, cognition, learning theory, memory, assessment, and experimental design. Topics are discussed and demonstrated in lectures and labs.

Lab Assignments You must be in attendance to participate in the lab. There is a written assignment for virtually every lab. The assignments are due at the beginning of the following weeks lab, but are typically handed in the same lab they are completed. When handing in be sure to include full name, student number and lab section, for example: Bill Bailey, Psych 110, Lab B. Most will be submitted into a drop box on D2L. Research Report (Dec. 10 th) You will be conducting research in this course. It will involve designing an experiment, collecting data, analyzing data, and writing up a report. You will be using APA style for your write up. Detailed descriptions for this assignment will be presented in labs. You may be required to read and evaluate other research reports. Lecture Attendance

Exams:

If an exam is missed with an excused absence, it is up to the instructor's discretion as to how the mark will be made up.

Studying

You should plan on a weekly minimum of 6 hours outside of scheduled class time for the completion of readings, assignments and for general studying.

Reviewing, filling out. and editing your lecture notes right after class is recommended.

Contact the instructor to clarify any confusing concepts.

Distributed studying has been proven to be far more effective than massed practice (cramming).

Testing yourself on the material (answering questions) is far superior to simply rereading notes/textbook. Class PowerPoint presentations will be uploaded to the class website.
