COURSE GUIDELINES & EXPECTATIONS

There are multiple components to this course:

Lectures: I am choosing to structure this course along four themes: the physical characteristics of the province, the primary economic sectors and associated politics, the cultural past and present, and the social norms that are uniquely British Columbian. Each week there will be a traditional two-hour lecture, normally on Mondays.

Assignments: There are ten assignments in the course all of which focus on specific facets of each of the province. You'll be given a week to complete a series of questions that pertain to a topic or a locale. Computer access will be required for most of the assignments as you will be referring you to a variety of websites and data sources.

Pick-a-Town-Any-Town Project: You will be asked to choose a town in British Columbia and prepare a five-page brief summarizing its attributes. One photo will be required, and the rest of the text will address the physical, economic, political and social personality of your town.

Readings: In this course, I would like to introduce you to the scholarship found in BC Studies: The British Columbia Quarterly. I will ask you to read six articles over the course of the term – most of them long and involved – that present scholarly research and perspectives on British Columbia. In the spirit of reconciliation, I have chosen readings that explore the broad theme of “Whose Land Is It?”, the title of the opening reading for the term and a present-day issue for all of us. These readings will be examinable and I will ask you to summarize each of them in a written submission.

Tests: There will be three tests this term, the first one on Wednesday, October 6th, the second on Wednesday, November 17th, and the third on Wednesday, December 8th. Each test will have a selection of short-answer, true or false, multiple-choice, and short essay-type questions.

There will be no scheduled final exam in the College exam week for this course.
