This course introduces physical geography by examining the natural environmental processes behind hazards like earthquakes, storms, landslides and floods. It examines how human development and planning can turn hazards into disasters, or effectively mitigate them. Current events are emphasized. Lab activities introduce physical geography techniques in a hazards context.

#### **COURSE GUIDELINES & EXPECTATIONS**

The course content and lab assignments will be posted on D2L. The course is broken in to 14 modules. Each week, there will be a link to each topic that provides lecture outlines, lab assignments and materials. Generally, there will be one lecture and one lab assignment each week.

There are two exams for the course: a midterm in October and take-home final exam in the exam period. Students who miss an exam for a valid reason must contact me within 24 hours with an explanation. In such cases, one makeup exam time will be scheduled, and all students needing it will be expected to attend.

Generally, there will be one lab assignment completed per lecture topic. Lab assignments will focus on applied learning in the area of physical geography, natural hazard assessment and mitigation. Please be prepared by bringing the following items to lab classes: ruler, calculator, pencil crayons or highlighters. The assignment due date will be at the beginning the subsequent lab period, unless otherwise instructed. A penalty of 5% per day will be imposed on late assignments. Late assignments will not be accepted after I have returned them marked. Anyone cheating or copying work will receive a mark of zero on the assignment.

Your term project will be to listen to a series of podcasts and complete the subsequent quizzes. You will listen to Fault Lines, a CBC podcast that will outline emergency preparedness plans and procedures, interview various experts in the field and feature dramatic enactment of how this predicted natural disaster will impact British Columbians in the 24 hours, 72 hours, one month, one year following and beyond. You will complete a series of online quizzes on D2L to assess your learning from these podcasts. Ideally, this will be completed throughout the term at your own pace. Please do not wait until the end of term to cram this in as it will take some time to listen to each episode.
