COURSE GUIDELINES & EXPECTATIONS

Classes will be lecture format with discussions. Students will be expected to read the assigned chapter(s) and participate.

Mid Term: 30%. Midterm to be done in class on, March 16, 2022 and will cover lectures and Chapters 1 through 6 inclusive.

Final Exam: 30%. Will be held **May 11, 2022.** The format for the midterm and final exam may consist of definition, short answer, multiple choice, matching and essay questions. And will cover Chapter 7 -14 inclusive.

Discussion Paper : 20 % - Discussion paper due on **April 29, 2022**. You will have spring break to work on this plus the time since midterm and lots of time before final exam. It is described below but 3-5 pages.

You will be guiding the reader through the criminal justice system. I want to hear you to create a story which shows how the police formed their grounds (what were they charged with; section of the Criminal Code, possible punishments indictable, hybrid or summary offence), what the steps they took to process the prisoner, how they got released (conditions?), probation officer actions, court system and where they might end up (Provincial or Federal Prison) and why. **Start early and work through the paper as we work through the class**.

This seems like a lot, but the goal is to show you understand the process. While the mark will consider the grammar and spelling. I care most about the flow and connections in the thoughts and that is where most of the marks will be.

Your paper will be marked on:

- 1) Content. This includes how well you articulate your thesis statement or your central idea or position; knowledge of the subject and how well you support your statement with facts by referring to the literature.
- 2) Organization: I am looking for an introduction, body and a conclusion. I am looking for a logical presentation of the more important parts with fully developed paragraphs with proper sentence flow
- 3) Mechanics: That is, the quality of your writing including grammar and punctuation. Please avoid using described as slang (e.g. cop vs. police officer), colloquial (e.g. referring to taking drugs as a 'fix") or cliché (e.g. time heals all wounds)
- 4) Referencing: references are cited using the APA format in a separate reference page. Only those resources within the body of the paper are to be listed in the reference page. References are to come from a variety of sources (e.g. journals, reports, agency data, books, etc.) and should reflect Canadian content.
- 5) Format: Minimum 3 pages and Maximum 5 pages in length. To be typed, one sided, double spaced, unbound, stapled in the top left corner, title page, number pages, 1" margin, Times New Roman font, 12 pitch.
- 6) It is to be handed to me at the beginning of class on April 8, 2022. Penalty for a late paper will be assessed at 20% per week. Students having a legitimate (as defined by the instructor) concern about meeting due date should consult with the instructor well in advance.
