CALENDAR DESCRIPTION

The course introduces students to the theory and practice of environmental management at the urban and regional scale. Specific management tools are examined, including environmental impact assessment, cost accounting and cost-benefit analysis, economic instruments, ecological footprint analysis, risk management, environmental reporting and auditing, and the ISO 14000 environmental management standard.

COURSE GUIDELINES & EXPECTATIONS

This is an applied, participatory course; the emphasis is on *application* of theory to practice in the field of environmental management. Guest speakers - consultants and government officials – are invited to discuss current practice. Several case studies and site visits within the local urban region are introduced to allow the student to critically examine local issues and policy. An emphasis is placed on project work, carried out either individually (three projects) or in small groups (one project). Students are expected to be fully involved in the course, by engaging in class discussions and exercises; and attending class events – guest speakers and site visits. **Students must achieve a minimum 70% participatory mark to pass the course.**
