#### **COURSE GUIDELINES & EXPECTATIONS**

1. There are two lectures each week that everyone attends.

Lecture #1: Overview of the assigned chapter.

Lecture #2: Chapter details.

2. Additionally, there is a one hour seminar each week. Half the class is registered for Seminar A, the hour after the first lecture each week; the other half of the class is

- registered for Seminar B, the hour after the second lecture each week. Please check your registration to find out which seminar is yours.
- 3. The work in the seminar includes short hand written assignments. Please bring paper and a pencil or pen (blue or black). These assignments will only be accepted in class; there are no make up seminar assignments. For full marks at least ten seminar assignments must be submitted and the assignments must show that the student has acquired the basic skills by the end of term.
- 4. If a student misses or knows they are going to miss the seminar they are registered in, they may attend the other seminar that week.
- 5. There are twelve homework quizzes set up on D2L, each corresponding to one chapter in the text. Each quiz is due by 10 a.m. on the day of Lecture #2. There is no time limit for completing a quiz, but 45 minutes is recommended. The quizzes are set up to show students the incorrect responses after their first attempt, and it allows a second attempt. Between the two attempts, the highest grade is the one that counts.
- 6. Each of the three tests is worth 25%. The first two tests will be written in class. The final test will be during the exam period, April 17-29. The date of the final exam will be posted by the College February 18<sup>th</sup>. If you miss a test or are going to miss a test, please contact me as soon as possible to arrange a date and time for a make-up test.
