## CALENDAR DESCRIPTION

---

Building on the technical, continuity and composition skills acquired in DIME115, students will explore the story formats of vignette, short non-fiction, and commercial promotion through the use of digital audio and video. Students will add to their fundamental camera operation skills by gathering audio and video in complex and difficult situations, and use editing techniques to create pieces which are both entertaining and informative. Students will be required to work both independently and in teams to complete assignments. Time and project management skills are emphasized to reflect the demands of the media production industry
