4. Evaluate in depth juvenile justice legislation (e.g. Youth Criminal Justice Act, Young Offenders Act) in terms of underlying philosophies and current interpretations (e.g. definitions & legal processes).
5. Identify and review current and critical issues relating to youth justice in Canada.
6. Identify future trends in social responses to youth crime and youth justice.

Writing requirement: A high standard of English composition is expected. Remember to carefully proofread all assignments before submitting them. Assignments must employ APA format, except that weekly short assignments do not require cover pages. All assignments must be original and produced for the purposes of this course alone. Students experiencing ongoing difficulty with writing assignments are encouraged to seek help at the Writing Centre.

Test policy: Tests must be written on the day and during the time period allocated. If you are unable to write a test due to illness, a note from a medical practitioner is required.

Course Completion requirement: Regardless of the number of points earned during the course, students will receive an “F” if they do not complete ALL components of the course. They must write the two tests, complete the major assignment and complete at least eight out of ten of the short weekly assignments.
