ENVR 208A covers scientific method, research methods, and project design. It also includes instruction on how to start and operate a small environmental consulting business. Elements of the course include time management, budgeting, accounting, business development, proposal writing and project management.

ABOUT THE PANDEMIC

- 3. Discuss the acceptable variation among completed ENVR 208B projects which focus on sustainability.
- 4. Develop a business plan for starting a small environmental consulting business.

COURSE CONTENT

The main purpose of this course is to get you started on the capstone sustainability project that you will complete in ENVR 208b. We will also review some business fundamentals of environmental consulting, a common context for this kind of work in the real world.

This course is scheduled in two 4-week blocks at the start and end of winter term. During those blocks, class will run from 12:30 to 2:20 on Tuedays in room F216. Course material, including readings, assignments, etc., will be posted on D2L (<u>http://online.camosun.ca</u>). <u>Class attendance is critical</u>. Be there, unless you are sick.

There are several assignments to complete for this class as enumerated below. The big one, and your primary focus, will be a formal proposal for your ENVR 208b project, to be submitted in written form and presented to the class. Detailed instructions will be provided in class and on D2L.
