COURSE GUIDELINES & EXPECTATIONS

Lectures: Attendance is essential. I will post basic lecture outlines on D2L. These outlines are no substitute for coming to class. Lectures are scheduled for the first class meeting per week as per the course schedule.

Readings are an essential part of this course – they provide depth and context that are indispensable to your understanding of the course material, and they will be tested. Specific reading assignments are detailed below; these may be modified as the term goes on. For each textbook chapter, there will be a quiz on D2L.

Assignments: A variety of assignments must be completed for this class.

- **Lab Assignments:** Lab assignments are intended to apply concepts learned in class, while practicing techniques of geographic analysis. Several assignments will use web sites, and will be taken home for completion. The lab due date will be at the beginning of the subsequent lab period, unless otherwise instructed. Labs will be handed in on D2L.
- **Plot study:** The plot study assignment will be introduced early in the course. You will choose a place that is representative of the area around which you live and will visit it frequently throughout the term. During these visits, you will make observations, collect images, and learn about its ecosystem components. You'll also research the human history of your plot and any the development protections or plans for it. At the end of term, you will summarize your findings in a format of your choosing (with guidelines).

- Exams: There will be three exams in the course. The format for these will be a combination of multiple choice, short answer and long answer questions. They mainly will emphasize the lecture material, and textbook reading. The exams will take place on D2L. The exams will not be cumulative

Labs and podcast assignments are generally due one week after they have been assigned. Late assignments will not be accepted after I have returned them marked. There will be no exceptions to this policy. Anyone cheating or copying work will receive a mark of zero on the assignment.
