List of topics:

The course is organized into ten topics:

Topic 1. Introducing the city

This chapter presents the concept of urbanization and global trends in urban growth. It presents the basic properties of the post-industrial city and it examines the influence of globalization on cities.

Topic 2. The Canadian urban system

This topic presents patterns of urbanization and trends in urban growth in Canada. It puts Canadian cities in world context by comparing them with European and American cities.

Topic 3. Patterns of land use in the city

This topic examines patterns of land use in the city. It presents Alonso's traditional land use theory and examines patterns of land value and population density in the city.

Topic 4. The downtown area

This topic examines the structure and functions of the downtown area. It highlights the planning issues in the area. It also examines the phenomenon of suburban downtowns.

Topic 5. Transportation in the city

This topic presents transportation patterns and analyzes the transportation issues in the city. It discusses transportation planning strategies.

Topic 6. Urban social space

This topic examines social and economic patterns of population distribution in the city. It presents the classic spatial models of urban form and the major results of factorial ecology. Finally, it discusses these patterns in the context of the postmodern city.

Topic 7. Housing and neighbourhoods

In this topic, we examine housing patterns and neighbourhoods. We contrast inner city and suburbs. We investigate issues of housing affordability and community coherence and stability. We present a classification of Canadian suburbs according to social and morphological attributes.

Topic 8. The sustainability challenge of cities

Here, we examine the urban eco-system and the environmental issues in the city. We investigate alternative models of urban growth and design.

Topic 9. Cities in developing countries

This topic examines the special challenges faced by cities in developing countries.
