CLASS GUIDELINES & EXPECTATIONS

- All assignments are due by 10pm on the due date. You will need to complete work in all areas to be eligible for a final grade for the semester.
- Assignments are to be double spaced, double-sided, Times New Roman 12-point font, and must include a title page, introduction, body, clear headings and a conclusion; it is also very important to use citations and references (APA Style) for anything that is from a source that is not your own thoughts, or it is considered plagiarism.
- Late Assignments: All assignments must be completed/submitted on the date assigned. Late assignment grades will be reduced by **5%** per day *unless* an extension is negotiated and approved by the instructor in advance of the assignment due date. To request an extension for an assignment, contact your instructor **no later than 48 hours in advance** of the due date, provide an explanation/rationale for requesting an extension and negotiate a revised due date. Approval is not guaranteed and is determined by the instructor. Extensions are not granted on the due date.

4. Follow APA writing guidelines. This includes formatting, spelling, grammar, in-text citations and references. Please remember to proof read for spelling and grammar to present a professional looking assignment.
5. It is the responsibility of each student to save a copy of all assignments until a grade is received.
6. Assignments will not be accepted after the last day of class at the end of term unless an extension has been granted prior to the due date. Assignments not received by this time will receive a zero.
7. Last day to withdraw from courses without a failing grade is December 10. If you withdraw by the posted withdrawal date, you will not be penalized. Withdrawal or incompleteness of work after the posted withdrawal date will result in an 'F' grade being assigned.
