#### 4. Course Content and Schedule

In this course students study the health/disease continuum from the viewpoint of various community groups. Included are issues about community dental health, oral health delivery modes, current concepts of health education, health promotion, and partnerships with community groups. JULEG

On completion of this course the student will be able to:

#### 1.0 Describe concepts of community health and community oral health.

- 1.1 Describe the development of community oral health
  - define community oral health
  - outline the history of community dental health
  - describe the political context of community health today
  - describe current national and provincial trends in the provision and financing of community oral health
- Describe the social context of community oral health today 1.2
  - describe how changes in disease patterns, technology, demographics and social change have created a need for a new model of health care delivery
  - explain sociological changes in family structure and changing roles of family members
  - explain how current local, provincial, national and global economics impact health care
  - discuss the implications of the above changes on the dental health of Canadians
  - identify and describe population health and health determinants
  - identify health promotion principles in selected agencies
- 1.3 Compare and contrast fundamentals of community health dentistry with private practice.
  - explain the differences in focus of the private practice practitioner and the community dental health practitioner

#### 2.0 Identify community oral health activities related to the prevention and control of oral disease and promotion of oral health, using a healthy community concept.

Describe preventive dentistry

- recall concepts of preventive dentistry (from DHYG150 and 151)
- place primary, secondary and tertiary levels of prevention on the health/disease continuum
- describe characteristics of an effective public health measure for prevention
- 2.2 Describe the roles of volunteer and career dental professionals, especially dental hygienists, in community oral health activities.
  - describe the involvement of oral health professionals for the prevention of caries, periodontal diseases, oral cancer, orofacial defects, malocclusion and accidents

Temporary Grade	Description
I	<i>Incomplete</i> : A temporary grade assigned when the requirements of a course have not yet been completed due to hardship or extenuating circumstances, such as illness or death in the family.
