### Dental Hygiene Health Care Planning

### 5. Basis of Student Assessment (Weighting)

Clinical:

Student's clinical practice will be assessed in each clinical session. Evaluating students in an authentic environment presents challenges in that each client is different and therefore no two experiences are identical. However, the benefits of authentic evaluation i.e. learning in a "real work environment" far outweighs the challenges by providing students with a range of experiences similar to the variety of clients a hygienist would see in a clinical setting.

Students will receive feedback on their performance in each clinical session. It is expected that students will apply feedback to improving their performance. Repeated feedback concerning difficulties in student performance indicates that the student is not maintaining satisfactory clinical skills. <u>Students must display effective use of all clinical sessions</u>

All outcomes must be met satisfactorily to complete the course.
