On completion of this course the student will be able to:

1. Describe and participate in community oral health activities related to the prevention and control of oral disease and promotion of health.
2. Describe partnerships between special population groups and health professionals that contribute to building healthy communities.
3. Describe the role of the dental hygienist as an agent for change.
4. Describe epidemiological concepts and trends as they relate to oral health.
5. Describe research methodologies related to community oral health.

4. Course Content and Schedule

This course is a continuation of DHYG 190. The emphasis is on promotion of oral health, as well as community dental health programming. Didactic information will be applied in the community through field experiences.

On completion of this course the student will be able to:

1.0 Describe and participate in community oral health activities related to the prevention and control of oral disease and promotion of health.

- 1.1 Recall concepts of preventive dentistry (from DHYG 190, 150 and 151)
- 1.2 Describe the involvement of dental professionals for the prevention of oral diseases

2.0 Describe partnerships between special population groups and health professionals that contribute to building healthy communities.

- 2.1 Discuss community health partnerships.
 - recall the concept of partnerships with community groups during the planning, implementation and evaluation of community programs (from DHYG 190)
 - discuss information and skills that help health professionals establish, maintain and improve partnerships with other health groups within the community
 - discuss community dental health in the context of healthy communities
- 2.2 Discuss challenges of working with special client groups:
 - discuss what is meant by 'client groups'
 - discuss the community health needs of different client groups
 - describe possible health inequities of client groups
 - discuss barriers to positive partnerships between health professionals and client groups
 - discuss interpersonal skills appropriate for working with client groups
 - discuss dental health, in the context of general health and family coping
- 2.3 Discuss community partnership dental programs for people in residential care.
 - discuss the residential care system
 - recall interpersonal skills appropriate for working with clients and their caregivers (from DHG 150)
 - discuss oral health status and appropriate interventions for special population groups living in residential care
 - describe factors to consider when planning community programs with special population groups in residential care including physical, social, and economic factors as well as levels of dependency
 - discuss ways of helping the clients and caregivers with challenges of care
- 2.4 Discuss community dental programs for school children
 - recall knowledge about presenting information to community groups (from DHYG 190)
 - discuss ways of presenting information to various ages of school children including appropriate interpersonal skills

- 3.0 Discuss the role of the dental hygienist as an advocate.
- 3.1 Discuss influence and change.
- recall knowledge of public presentations
 - discuss factors to consider when attempting to influence others
- 3.2 Discuss the participation of dental hygienists in health initiatives.
- define 'health initiatives'
 - explain the recent history of dental hygiene involvement in health initiatives
- 4.0 Describe epidemiological concepts and trends as they relate to oral health.
- 4.1 Describe epidemiology.
- define epidemiology
 - describe uses of epidemiology for community dental care
 - differentiate between descriptive, analytical and experimental epidemiology
 - differentiate between prevalence and incidence
 - describe the strengths and limitations of cross-sectional, longitudinal, cohort, case study and retrospective follow-up types of analytical epidemiological studies
- 4.2 Describe dental indices used for epidemiological studies.
- differentiate between individual clinical indices and clinical trial indices
 - describe characteristics of an effective and useful index
 - describe the purpose and methodology of the following dental caries indices: DMFT and DMFS
 - describe the purpose and methodology of the following oral hygiene indices:
 - Green and Vermillion's OHI and OHI-S, O'Leary's Plaque Control Record,
 - Silness and Loe's Plaque Index
 - describe the purpose and methodology of the following periodontal indices:
 - Russell's Periodontal Index, and C.P.I.T.N.
- 4.3 Describe oral health trends.
- describe the relationship between host, agent and environment
 - discuss future dental epidemiology trends due to changes in host, agent and environmental factors
 - recall the impact of lifestyle practices on oral health
- 5.0 Describe research methodologies related to community dental health.
- 5.1 Describe community dentistry research literature.
- recall knowledge of components of a scientific report (title, abstract, introduction, review of the literature, materials and methods, presentation and analysis of data and conclusions) (from DHYG 151)
 - apply knowledge of scientific reports to community dentistry research reports
 - define "refereed" journals
 - identify journals publishing original research in community dentistry

Temporary Grade	Description
