Upon completion of this session, you need to be able to:

- 2. Review content and uses of emergency kit.
- 3. Review use of oxygen in case of need in a medical emergency
- 4. Demonstrate Camosun College emergency protocols for earthquake, client emergency care (PERT) and percutaneous and mucous membrane injuries

Instrumentation Review on Student Partner

Upon completion of this session, you need to be able to:

- 1. Practice professionally, safely, ethically following infection control guidelines and clinical protocols
- 2. Demonstrate the fundamentals of instrument sharpening including moving instrument-stationary stone technique
- 3. Demonstrate the fundamentals of exploring, indirect vision and instrumentation using a variety of instruments

- 1. Perform a screening on a peer client.

Power Scaling Instrumentation. Review of Piezo tips Standard, P, PS, PL 1 and PL 2 (right and left)-and introduce-Magnetostrictive FSI 1000 and Curved tips (right and left)

- 5. Document appropriately according to CDHBC guidelines

Supra and Subgingival Air Polishing

Upon completion of this session, you need to be able to:

- 1. Demonstrate fundamentals of air polishing both sub and supragingivally including unit set up, maintenance, and technique on a student partner.
- 2. Choose an appropriate air polishing agent for specific applications.

Pit and Fissure Sealants

Upon completion of this session, you need to be able to:

- 1. Identify and provide rationale for sealant placement.
- 2. Demonstrate fundamentals of sealant placement and evaluation on a student partner
- 3. Document appropriately according to CDHBC guidelines

Children and Youth

Upon completion of this session, you need to be able to:

- 1. Employ the ADPIE process of care for children and youth clients.
- 2. Determine and perform modifications such as knee to knee examinations and behaviour management strategies when providing the process of care to child and youth clients
- 3. Analyze assessment findings for children of various ages.
- 4. Generate approaches to involve parents in self-care with children in the office and home environments.
- 5. Identify signs and symptoms of child abuse and the dental hygienist's role in advocacy for the protection of children.
- 6. Document care according to CDHBC guidelines for documentation.

Manual and Advanced Instrumentation

- 1. Utilize accessory instruments for complex periodontal debridement on clients.
- 2. Utilize effective methods and instruments for debridement of appliances and implants.
- 3. Problem solve challenges that can occur during debridement

Ergonomics and Advanced Fulcruming

Upon completion of this session, you need to be able to:

- 1. Demonstrate ergonomic positioning for reinforced periodontal positioning including standing position
- 2. Determine when advanced fulcruming is needed to support instrumentation principles for clients with complex needs.
- 3. Demonstrate advanced fulcruming during debridement.
- 4. Perform strategies to support long term clinician health during the provision of hygiene care

Pulp vitality

Upon completion of this session, you need to be able to:

- 1. Identify sources of tooth sensitivity.
- 2. Determine the health of the pulp (including but not limited to ice, percussion, heat, radiographs, electric vitality testing).
- 3. Discuss causes, diagnosis and treatment of reversible and irreversible pulpitis.
- 4. Document appropriately according to CDHBC guidelines.

Professionally Applied Subgingival Irrigation

Upon completion of this session, you need to be able to:

- 1. Demonstrate the use of subgingival irrigation in the prevention and treatment of inflammatory periodontal disease
- 2. Identify and use the various modes of delivery available for application of chemotherapeutics in professional settings as needed.
- 3. Document appropriately according to CDHBC guidelines.

Impressions

Upon completion of this session, you need to be able to:

- 1. Demonstrate effective technique to acquire a useful impression for sport guard and whitening tray fabrication.
- 2. Apply strategies to maximize client comfort.
- 3. Demonstrate effective technique to acquire an inter-occlusal wax bite.
- 4. Apply appropriate infection control procedures while taking impressions and prepare the impression for pouring.
- 5. Document appropriately according to CDHBC guidelines.

Pouring and Trimming Study Models

- 1. Utilize safety protocols in the laboratory setting following infection control guidelines.
- 2. Demonstrate effective mixing and pouring of dental stone into impressions.
- 3. Demonstrate trimming according to guidelines for a working model and effective horseshoe trim of study model suitable for sports guard and whitening tray fabrication.

Sport Guard Fabrication

Upon completion of this session, you need to be able to:

- 1. Determine the most appropriate type of sport guard using a client centered approach.
- 2. Demonstrate safe lab techniques following infection control protocols.
- 3. Employ best practice standards for the fabrication of sports guards.
- 4. Provide appropriate self-care instructions for sports guards to a client.
- 5. Deliver a custom sport guard to a peer/client.

Whitening Tray Fabrication

Upon completion of this session, you need to be able to:

- 1. Demonstrate safe lab techniques following infection control protocols.
- 2. Employ best practice standards for the fabrication of a custom whitening tray.
- 3. Delivery of whitening system to client/peer.
- 4. Monitor and evaluate delivery of whitening system.

Administration of Local Anesthetic

Upon completion of this session, you need to be able to:

- 1. Demonstrate safe and effective acceptable administration of intraoral maxillary and mandibular injections.
- 2. Calculate dose administered and compare to safe doses and document appropriately.
- 3. Problem-solve issues that arise with the administration of local anesthetic.

Facilitating Learning with DHYG 271 students

Upon completion of this session, you need to be able to:

- 1. Assess the instrumentation abilities of a second year student.
- 2. Provide constructive feedback to a second year student.
- 3. Support the second year student in self-assessing their abilities.
- 4. Facilitate the acquisition of instrumentation abilities by the second year student.
- 5. Evaluate the outcomes of the learning session with input from the second year student.
- 6. Guide the ADPIE process of care for a second year student while being their mock client.

IRM Temporary Restorations, Instrument Transfer, Rubber Dam, Margination

- 1. Demonstrate satisfactory mixing, placement and finishing of IRM in a Class II cavity preparation on a manikin.
- 2. Transfer instruments safely to a peer during IRM placement.

- 3. Employ best practices to place a rubber dam on a manikin
- 4. Utilize a variety of discs, strips and instruments to marginate composite and amalgam restoration on manikins.
- 5. Document appropriately according to CDHBC guidelines.

Clinic Maintenance and Instrument Kit Review

Upon completion of this session, you need to be able to:

- 1. Complete clinic maintenance procedures
- 2. Evaluate instruments for replacement

During all clinical sessions when working on peers or clients students must:

- Consistently demonstrate professional behaviour.
- Demonstrate consistent accountability and responsibility for decisions and actions.
- Communicate effectively with people involved with care.
- Maintain infection control and safely operate equipment.
- Practice ergonomically to support personal health.
- Manage the practice environment to support client safety, comfort and wellbeing.
- Integrate evidence and theory from the behavioural, oral health and general health sciences into the dental hygiene process of care.
- Manage records using approaches and terminology that meet medico legal and ethical standards and that comply with the CDHBC documentation guidelines.
- Maintain confidentiality of client information and records.
- Self-evaluate clinical performance using instructor and peer input.
- Integrate the ADPIE process to provide holistic, comprehensive and quality dental hygiene care.

Assessment

- 1. Internalize and consistently demonstrate an efficient sequence and technique to ensure accurate, thorough and complete assessment.
- 2. Assess clients of variety of age groups including children and youths.
- 3. Competently assess clients presenting for preventive and periodontal maintenance as well as children and youth in a maximum of two appointments.

Diagnosis

- 1. Utilize relevant assessment data to accurately determine risk for conditions affecting the oral complex including caries, periodontal diseases, oral cancer, and sleep apnea.
- 2. Utilize relevant assessment data to create accurate dental hygiene diagnostic statements.
- 3. Accurately determine the American Academy of Periodontology (AAP) periodontal classifications with minimal guidance.

Planning

- 1. Plan dental hygiene care based on assessment data, diagnosis, social determinants of health, prognosis, client values and expectations for clients of a variety of ages including children.
- 2. Utilize the Human Needs Model and consider social determinants of health in the planning process.
- 3. Determine SMART goals (specific, measurable, attainable, realistic, timely) for client care.
- 4. Utilize principles of health promotion in the planning process.

Implementation

- 1. Provide all planned interventions.
- 2. Demonstrate sound, safe and effective instrumentation
- 3. Evaluate clinical end-point based on tactile detection and tissue response on clients of varying challenges.

Evaluation

- 1. Evaluate the actual outcomes against expected outcomes to determine the success of dental hygiene care
- 2. Summarize plan, care and prognosis, including setting appropriate care intervals and any necessary referrals

Chart Audit and Quality Assurance

- 1. Perform chart audits to ensure documentation of care is complete and accurate and complies with CDHBC documentation guidelines.
- 2. Perform quality assurance audits to ensure the provision of complete, comprehensive quality care for all clients.

Radiographs and Imaging (during radiography lab sessions and client clinics)

- 1. All radiographs taken on clients' or on Dental X-ray Teaching Training Replica's (DXTTR's) require adherence to radiation safety and protection guidelines.
- 2. Identify when radiographs are required for caries detection or periodontal assessment with assistance.
- 3. Successfully expose a full mouth series of digital radiographs (minimum of 12 films in one hour) on a client following clinic protocols.
- 4. Use appropriate interpersonal skills and strategies to increase the client's physical and psychological comfort during radiograph exposures.
- 5. Complete the following dental radiographs and / or exercises: pedo full mouth series (bisecting the angle technique), occlusal, localization, distal oblique, digital films and panorex with minimal assistance.
- 6. Process radiographic films automatically, following infection control guidelines, with minimal guidance.
- 7. Assess the diagnostic acceptability of all images taken, problem-solving any deficiencies, with guidance.
- 8. Interpret radiographs, identifying normal anatomic landmarks, restored conditions, periodontal status, caries, artifacts and suspected pathologies etc.
- 9. Describe components to set up for imaging including camera and computer and demonstrate infection control required for intraoral imaging.

- 10. With a high-resolution camera, take a set of images commonly used in a case presentation (i.e., portrait, lateral head view, full anterior view, occlusal). Details to be provided during lab sessions.
- 11. Manage digital and paper files using transfer and storage protocols, with appropriate consent from clients (radiographic and digital images)
- 12. Document all exposures and/or images as required in client records.

6. Basis of Student Assessment (weighting

The student must satisfactorily:

- 1. Meet all course learning outcomes
- 2. Submit Self-Evaluation and Progress Report at week 4, mid-term and end-of-term on D2L
- 3. Complete all documentation required for client care (including chart audits and quality assurance)
- 4. Satisfactorily complete all formative and summative evaluations by due dates as indicated on summative/formative form.
- 5. Complete all client requirements by the end of term.

Evaluating students in an authentic environment presents challenges in that each client is different and therefore no two experiences are identical. However, the benefits of authentic evaluation (ie: learning in a "real work environment") far outweigh the challenges by providing students with a range of experiences like the variety of clients a hygienist would see in a clinical setting.

Instructors meet regularly to review student performance. Students are assigned clinical advisors. Advisors are available to assist students in understanding their clinical feedback.

Clinical Expectations:

Attendance is required for all scheduled teaching and client clinical sessions.

- Notification if away: Students who must be absent due to health or other emergency reasons are to notify the respective DH2 or DH3 lead clinic instructor, the clinic advisor and the Instructional Assistant by email first thing in the morning (or sooner).
- Students may be assigned additional clinical duties if a clinic is missed to meet the learning outcomes.

Professionalism and Deportment

- Students must demonstrate professionalism and deportment at all times.
- Students must come to mid and end of term meetings prepared (ex. Tracking is up-todate, all documentation is completed including appropriate signatures).
- Students must demonstrate self-directed learning (ex. managing clients through appropriate scheduling and planning, etc.)

Student Clinic Binder

Each student is responsible for maintaining their own complete and accurate clinic binder containing the following information. This binder must be up to date (signatures, tracking completed, forms filled out) by Friday of each week.

- Weekly Progress Record for each week with remediation deliverables attached
- Summary of client care for each client (child, preventive, periodontal maintenance, periodontal therapy)
- Client Care Tracking Forms
- Summative and Formative Skill Forms associated with each evaluation
- CA, Screener and Reception Forms
- Radiography Requirements
- Local Anesthetic Requirements
- 4 Week Self-Evaluation, Midterm and End of Term Self-evaluations and Progress reports

Binders must be kept in a locked file cabinet located at the teaching end of the clinic and **may not leave the clinic area**. It is the student's responsibility to ensure the safe keeping of these documents and grades. If any Weekly Progress Record or Summary of Client Care forms (grades) are lost the student must complete another client to make up for the loss. During clinic, the binders must be chairside and be available for instructors.

Instruments: Students must have two full sets of instruments in good condition. Instructors will assist in evaluating instruments. Unsafe instruments must be immediately removed from student kits and replaced as soon as reasonably possible.

Student Rotations for Clinic

The class is divided into four teams (three for teaching clinics). Units for each team will be assigned by section. Students are required to utilize assigned units whenever possible. Three Clinic assistants will be assigned to all clinics; one of which will be a screening clinic assistant. Reception duties are also assigned. In extenuating circumstances, students may exchange scheduled dates with peers **and are required to record all changes on the master list in the dispensary and let the Clinic Supervisors and the Instructional Assistant know of changes.**

Daily Preparation for Clinic

As an adult learner, it is the student's responsibility to participate in the learning process and to be prepared to ask/answer questions and participate in discussions. It is expected that the student will have completed all assigned pre-reading for preparation to practice each procedure in the clinic, to achieve competence in clinical procedures, and to provide comprehensive dental hygiene care with clients.

7. Grading System

Competency Based Grading System (Non GPA)

This grading system is based on satisfactory acquisition of defined skills or successful completion of the course learning outcomes

A. Temporary Grades

Temporary Grade	Description
I	<i>Incomplete</i> : A temporary grade assigned when the requirements of a course have not yet been completed due to hardship or extenuating circumstances, such as illness or death in the family.
