# COURSE DESCRIPTION

This course introduces the learner to the profession of dental hygiene. Current concepts of practice are examined, with an emphasis on roles, responsibility, and accountability of the dental hygienist within the profession of dental hygiene, the healthcare system, and professional organizations. Medical, legal, ethical principles, laws and practice standards are explored. Concepts related to health promotion, population health and determinants of health as they apply to the role of the dental hygienist are discussed.
