COURSE DESCRIPTION

This course builds on DHYG 245 and introduces the learner to the skill set of a dental hygienist, including concepts relating to evidence-based decision-making, teamwork, communication, and cultural competence. Strategies for systematic enquiry and assessment of professional and scientific literature are examined. Partnerships between population groups and health professionals, as well as the role of dental specialists are explored. The role of dental hygienist as an advocate is also discussed.

ACTIVITY

Class Hours: 4 hour / week x 16 Weeks

1. Describe skills necessary for dental hygienists to participate in and collaborate with dental hygiene and inter professional teams and client groups

a. Understand and identify sources of professional information that will assist you in your professional decision-making. Learn to critically appraise evidence for validity and usefulness

b. Discuss teamwork and collaboration in dental hygiene practice, including the understanding of team roles and conflict resolution

- c. Understand the elements of communication and the skills necessary for optimal delivery of care
- d. Examine skills for creating a supportive environment
- e. Discuss teaching and learning approached for encouraging adherence
- f. Discuss the influence of culture on communication
- g. Examine assertiveness versus aggressiveness and implicit and explicit coercion
- h. Discuss ways of problem solving professional differences
- i. Learn the elements of proper presentation skills with individuals and groups

2. Assess professional and scientific literature relevant to dental hygiene practice

- a. Describe contemporary research topics and various types of professional reports
- b. Explore and recall various citation styles for literature referencing

c. Examine part of a journal article (Abstract, introduction, review of existing research, purpose of the research, methods, findings, analysis/discussion of the findings, recommendations for dental hygiene practice, recommendations for future research)

d. Recall quantitative and qualitative methods of evidence including various tests for validity

3. Identify and describe research strategies for systematic inquiry related to evidence based dental hygiene services

a. Discuss the use of technology to access information in consideration of research ethics, copyright guidelines and approval

- b. Discuss sources of support available for dental health research
- c. Identify various research designs and describe the scientific research process
- d. Discuss and explore writing a PICO question
- 4. Describe partnerships between population groups and health professionals
- a. Recall the principles of health promotion and the five actions as outlined by WHO
- 5. Describe the role of dental specialist in relation to dental hygiene practice
- a. Discuss the dental hygiene role as it refers to other health professionals
- 6. Describe the role of the dental hygienist as an advocate
- a. Discuss factors that create influence and change for and in others
- b. Discuss the participation of dental hygienists in health initiatives, including the recent history of dental
- hygiene involvement in health initiatives
- c. Explore personal barriers to oral health such as level of control and dental related fear and anxiety
- d. Discuss leadership and the change process
