COURSE OUTLINE

Course Description

This course examines developmental theories that explain human growth from conception to early childhood. Current research in developmental research is explored. The image of the child in society and the influence of family and culture on children's growth are addressed. Application of theoretical knowledge to early childhood practice is emphasized.

3. Required Materials

ATTENDANCE:

Due to the short and intense nature of the ELC program, classes are planned as a continuum for building the skill and knowledge required. Please note that if you are observing in an early learning program and you have not already done so. you will probably need to go through a criminal record check. The agency can assist you in filling out the forms.
